Animal Rescue Coalition does not offer adoption services; ARC is solely a Spay/Neuter organization working closely with many local rescue groups and animal service agencies as well as the general public providing low-cost, full sterilization services needed. ARC offers Spay/Neuter services to animals as young as 4 months who are up-to-date with all vaccinations and in good health. Pet owners are instructed to contact our scheduling line to book their S/N appointment. ARC is open Monday through Friday. Pets are dropped off at 8:00 am released at 4:00 pm. ARC offers re-checks in case of emergency and/or major concerns free of charge.

Animal Rescue Coalition is a Spay/Neuter organization founded in 1999 to offer low cost services to the low-income population of Sarasota and Manatee counties. Since our founding, ARC has spayed and neutered more than 40,000 dogs and cats, preventing countless generations of innocent animals from entering a world without enough homes for them, thus facing inevitable euthanasia. In addition to the proactive low-cost and high-quality Spay & Neuter Program, the Emergency Medical Fund (EMF) Program has allowed ARC to work closely with the Sarasota County Animal Services and Bay Road Animal Hospital to rehabilitate injured, abused and sick animals who are still adoptable but without the EMF's treatment, would otherwise be euthanized. ARC's Feral Cat Program has also dramatically reduced overpopulation in many feral colonies in our region. ARC is proud to be one of the 140 plus Humane Alliance clinic's in the country and carry out its nationally recognized tried and tested high-volume, high-quality, low-cost companion animal sterilization model. In November of 2014 ARC opened doors to a modern, fully-equipped, 3,800 sq/ft spay & neuter facility. ARC contracts three Florida licensed veterinarians who work on a rotational schedule and three full time trained veterinary support personnel in addition to two full-time administrative staff.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

ARC receives funds through a number of sources including grants, special events, private donations and a small county reimbursement program. ARC highest source of income comes from its main annual fundraising event, representing 30% of the revenue. In order to increase and expand ARC's spay/neuter services a Transport Program is currently being implemented. This program is designed to reach outlying areas where limited spay/neuter is available. Low-income families will have the ability to meet ARC's coordinator at a central location and drop their animals to be transported to ARC's clinic for surgery. Animals will return to their owners the next day. With this grant, ARC will offer FREE spay & neuter services in the northern part of Charlotte County

where high concentration of animals is present and poverty is prevalent.

The area selected is one of the most populated and poorest areas in Charlotte County. The income growth rate is about the same as the state average rate of 21.87% and is lower than the national average rate of 26.32%.	
Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:	
Due to lack of resources and information, there is high rate of overpopulation in the area selected. Unsterilized community/free-roaming cats are great source of overpopulation and owned dogs who are not altered, are allowed to roam, posing a huge threat and increase rate of unwanted pets.	
What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?	
There is very limited source of low-cost and high-volume spay & neuter services in the targeted area. Animal organizations such as St. Francis Animal Rescue and Sarasota Defense of Animals (SDA) will provide free spay/neuter services when funding is available. These limited resources are not nearly adequate for the quantities of sterilizations needed. ARC's new high-volume S/N clinic and Transport Program can meet the demand for services in that area.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

ARC is proud to be one of the 140 plus Humane Alliance clinic's in the country and to carry out its nationally recognized tried and tested high-volume, high-quality, low-cost companion animal sterilization model. With this grant ARC will provide approximately 500 sterilizations to owned pets of low-income families in the targeted area. This program will not stop after the grant is used. It is our goal to continue providing services to that zip code and neighboring areas that face the same need of FREE and low-cost Spay/Neuter services. ARC plans to apply for additional grants as well as private funding through donors and fundraising events in order to continue making an impact in these poverty prevalent areas.

How does this program increase the number of sterilization surgeries above the existing baseline?

ARC performs an average of 15-20 surgeries a day. With a new fully-equipped facility, ARC is able to accommodate 20-25 surgeries daily. Reaching out to areas outside our walk-in traffic, will not only increase our volume, it will also offer a solution to the financial challenge of pet owners in Charlotte County who cannot afford private veterinarian services and do not have options of low-cost spay

& neuter in their community.

Methods

What criteria will you use to determine eligibility for your program?

Low-income criteria as determined by government standards and guidelines. To qualify, clients must fall under Federal TRIO and be receiving any of the following government subsidies: Food Stamps, Social Security Disability, Medicaid, WIC and School Lunch for Children Program.

How will you advertise the program? Explain how the advertising will reach the target audience.

ARC will prepare educational materials(with ability to offer bi-lingual material as well) to reach the target audience. Meetings will be arranged with local rescue groups and county animal control officers and materials will be directed to selected zip code and distributed accordingly. Working closely with the local community and reaching out to feed stores, churches, community organizations, schools, diners and all establishments where the target audience is likely to be present, ARC will distribute flyers, and also utilize a variety of traditional media, social media and web based tools including Facebook, Craig's List, and ARC's own website.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

ARC's outreach program addresses the transportation challenge at its core. ARC's Transport Program is equipped and prepared to reach pet owners where they reside. Working with a local community partner/coordinator, pet owners will be able to schedule their S/N appointments and will be notified day/time and location where to meet the transport vehicle. Two of ARC's full time staff are fluent in Spanish and materials are available in both Spanish and English.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

If pet owners are not able to transport their animals to the clinic, ARC's new Transport Program will meet that need. The transport program is a successful, safe and efficient initiative implemented by the Humane Alliance and used by most of the 140 and plus Humane Alliance clinics in the country. Its proven method of effectiveness includes a comprehensive system of appointment scheduling, pick-up and delivery of animal. The transport vehicle is properly equipped for safe transport of animals. All families participating in the transport program are asked to sign a release of liability form based on Humane Alliance recommendations and customized for ARC and Florida residents. The transport driver will be subject to random drug testing and will be properly trained by Humane Alliance representative for the care and handling of the animals. ARC's full staff have been trained at the Humane Alliance headquarters in Asheville, NC to learn all the steps and logistics of documenting, handling and transporting animals.

ARC currently outsources its veterinary personnel and has a rotation of three licensed professional vets providing spay/neuter services at ARC's clinic. Dr. Jerry Edington, DVM has over 20 years of veterinary practice and serves as ARC's lead veterinarian and medical director.

The above price structure is the average low-cost per animal per surgery that ARC uses. For this particular grant, ARC will cover the cost of rabies vaccine and will offer microchip as an optional item at \$10.00 per animal.

Customers will be required to present proof of income and residence. They will be asked to retrieve voucher either through ARC, Charlotte County Animal Control and/or partnering organization/volunteer. ARC will track vouchers and confirm proof of residence of selected targeted area and income on day of surgery.

For your voucher program, how have you determined the capacity of the veterinarians listed above to handle the projected capacity?

ARC's veterinarians are Humane Alliance trained and experienced with high volume S/N program. ARC is able to handle 25 - 30 a day.

Will you have the ability to report the number of vouchers issued and the percentage that result in S/N surgeries?

Yes. ARC has a sophisticated software which is designed specifically to track spay and neuter surgeries and provide diverse and comprehensive reporting.

This grant will provide S/N services in an area of critical need. The impact is crucial and will enhance the quality of life of many animals in the community as well as reduce overpopulation. In order for this campaign to be successful, a comprehensive plan will take place with all partners, community groups and ARC's medical/administrative staff. Detailed spreadsheets containing information (community cats and private pets, spay/neuter projections, surgeries and results, contact information, locations, and expenses) will be tracked and monitored to ensure goals and planned strategies. We are confident that this project will generate positive results in our mission to address overpopulation and euthanasia rates as seen in other communities where ARC has implemented its signature high-volume, high-quality and low-cost spay & neuter program. An example of such successful effort is Sarasota County Animal Services which has experienced a long partnership history with ARC. In 2014 SCAS brought in 3,147 dogs and cats into their shelter. Of these 449 were released through adoptions, 989 through transfers and 927 were returned to their owners. This translated to a live release rate of 75% and SCAS has attributed this increase to ARC's proactive Spay & Neuter and Emergency Medical Fund programs.

ARC will cover all expenses related to S/N surgeries including the cost of rabies vaccine. ARC will also cover all transportation expenses including fuel and supplies. Microchip is optional and ARC will offer microchip \$10.00 per animal.

In November 2014 ARC received a \$70,000 grant to assist in the purchase of the transport vehicle from the William G. and Marie

Selby Foundation and an additional \$5,000 grant from the Bernice Barbour Foundation to offer free S/N to low-income families at a targeted Sarasota County zip code . Additional funding for S/N Program is generated from ARC's annual fundraising gala, private donations and operating budget allocation.

What percent of the total cost of the program would this projected grant cover?

Future Funding to Sustain Public Spay/Neuter

The generosity and commitment of ARC's board of directors and donors who stand 100% behind its quest to help our local community to achieve a no-kill status, coupled with its achievement as a Humane Alliance business model will foster the level of sustainability required to carry out projects such as this one. ARC will continue pursuing other grants through local, state and national foundations, private donors, corporate sponsorships as well as special events. ARC's has had a history of successful annual fundraising galas. The 2014 and 2015 annual galas grossed \$207,912 and \$212,211 in revenue respectively with all proceeds going towards the operating cost of Spay/Neuter, TNR and Emergency Medical Fund programs. ARC is financially sound and committed to following the Humane Alliance operating model not only to ensure its long term business sustainability but also to expand its mission of saving animals for the benefit of humanity.
