North Florida Animal Rescue was founded in 2011 as a full service adoption facility, with the animal health center added on thereafter. The organization was rededicated to providing affordable spay/neuter services and veterinary care to the public in the summer of 2014, when a new team was hired to run the facilities. The updated services and purpose of the North Florida Animal Rescue is to provide limited adoption facilities and large scale low cost spay and neuter options as well as limited wellness clinic services to anyone in the surrounding communities. Currently, North Florida Animal Rescue provides lower cost spay/neuter surgeries for up to 70 publicly owned animals per week. Through having an in-house veterinarian that is dedicated to high volume spay/neuter, we were also recently able to partner with North Florida PAWS to complete the sterilization surgeries provided through their Florida Animal Friends Grant. Additionally, North Florida Animal Rescue frequently provides spay/neuter services at a discounted rate to Lake City Humane Society and TNR services to Covenant Pet Trust as well as other private trappers and colony caretakers in the area. Our staff includes: 1) Dr. Elizabeth Moses, in house veterinarian, whose experience includes performing spay/neuter services and shelter medicine at the Humane Society of Tampa Bay and SPCA Florida in Lakeland, Florida. 2) Heather Keeler, Director of Operations, whose work history includes Secretary of Labor of Love Rescue, as well as Humane Society of Tampa Bay and SPCA Florida with over 7 years of technician experience additionally. Volunteers include Katie Rooney, Director of North Florida PAWS, Inc., and Doug Rooney, among others.

# If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

PRODUCTIVITY: Since the rededication in the summer of 2014, we perform veterinary services for the public 4 days per week, which includes low cost wellness care as well as spay/neuter procedures. Each day that we provide veterinary services we generally perform between 10 and 15 sterilization surgeries, which amounts to having spayed or neutered over 984 animals within that time frame. This number does include animals that come in under our Community Cat program. FUNDING: Expenses are paid for through clients' payments and donations. Additional resources are needed to allow the daily surgery output to increase to 18 to 20 animals per surgery day in order to cover staff and supplies. In particular, this grant will be used to supplement the cost of spay surgeries for low-income pet owners whom are recipients of a federally funded assistance program, such as Medicaid, Social Security, or Food Stamps. In this manner, the funds would be allocated to those most in need.

# Objectives

## What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

Increase the projected number of spay surgeries by 25% per year from 1,475 to 1,850, specifically targeting those low income pet owners who cannot afford our already lowered costs. After the grant subsidy is applied, there would be a \$10 co-pay charged per animal.

#### How does this program increase the number of sterilization surgeries above the existing baseline?

The subsidy would result in an average savings of \$50 per surgery, the program would allow our facility to expand its client base to include a new and needy group of pet owners. As the majority of these pets are housed outdoors, every additional spay surgery will immediately prevent females from producing unwanted litters.

Any applicant for the subsidized program must show proof of enrollment in a federally funded assistance program, such as a Medicaid card, a Food Stamps card, or proof of Social Security.

The information will be added to our website and flyers, as well as distributed to other area rescues such as the Hamilton Humane Society, North Florida PAWS, and the Lake City Humane Society. We also will place advertisements in the regional news media.

We will have versions of the aforementioned flyer available in Spanish to include the Hispanic community in the region. Also, through a partnerships with North Florida PAWs and our volunteers, we will be informing the sometimes overlooked subsections of our community through word of mouth and direct contact.

Rabies vaccinations and pain medications are the only additional requirements for which we would charge a fee of \$5.00 each. A rabies license is automatically provided at no charge to all animals that recieve a rabies vaccine at our facility. It the client has paper proof of a current rabies vaccination, the requirement would be waived. A take home prescription of Carprofen or Tramadol will be provided to all animals receiving surgery. The physical examination is a hands-on evaluation of the pet to establish it's eligibility for surgery and does not include any other laboratory testing or diagnostics. Ear tips will be done if requested. All other vaccinations, test, and other services will be made available at the low cost originally provided through our clinic. No other 'hidden' charges will apply such as disposal or office visit fees.
