Protectors of Companion Animals has been providing affordable services to animals since its inception in 2001. In 2010, under the leadership of Sheila Westerveld, the organization focused on providing affordable spay/neuter services to the residents of Central Florida. Since that time, she has successfully procured grants for spay/neuter services from Alley Cat Allies and Petco. She has overseen other grants awarded to the organization from Pit Bull Rescue Central. She has also coordinated efforts with other local organizations for spay/neuter services by providing a \$3000 grant to Dollies Foundation for targeted TNR spay/neuter services in the Sanford, FL area.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

Until this year, SNIp-it of Central Florida provided a spay/neuter referral service to residents of Central Florida using the relationships they developed with local vet clinics in Orange and Seminole Counties. SNIp-it is opening a low cost spay/neuter clinic in Kissimmee located within Osceola County. Osceola County does not have affordable spay/neuter services. The average spay/neuter cost in Osceola County for a female and male cat is \$262.00 and \$217.00 respectively. The demographics surrounding the proposed clinic location demonstrate that it is situated in an underprivileged area of the County. As of 2008-2012, the per capita income of this Zip Code is \$20,584, which is lower than the state average of \$26,451 and is lower than the national average of \$28,051. In 2014, Osceola County Animal Services received 9140 animals, more than half of which were cats and kittens. Of the 4805 cats/kittens, 75% were euthanized. 2015 was marginally better at 68% of cats/kittens euthanized. The SNIp-it clinic will be the first high quality, high volume low cost spay/neuter clinic in Osceola. It is modeled after the premier business model of the Humane Alliance of Asheville, NC. It will perform 7000 surgeries annually. This is the same business model used by Spay N Save which has been operating since July 2012. In the 2 years since they opened their doors, the Seminole County shelter has noticed a decrease in the intakes of cats and dogs by 10% but more impressive is the drop in kitten and puppy intakes by 25%. Cats have the highest rates of intakes and euthanasia in the local government shelter and this grant can be the start to reverse these numbers in a fairly short amount of time.

Please explain if you believe your target area animal population is significantly different than above.

In 2015, approximately 35% of the total intakes were from within the city limits of St. Cloud and Kissimmee. BVL is part of Kissimmee but it is not an incorporated City and therefore, it is not included in the 19% of intakes from Kissimmee. Kissimmee and St. Cloud are the only two incorporated Cities in Osceola County. Based on last year's numbers, approximately 3,220 animals were received. However the actual number is probably much higher since there are other areas that have Kissimmee and St. Cloud mailing addresses that are not actually inside the City limits. Osceola County includes approximately 100,000 acres of undeveloped land leaving the potential for overwhelming increases in the human and pet populations in the near future. The Total population in the County is up 20% from 268,685 in 2010. We need to address the problem now. This grant will jump start the process.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:

The primary reason for overpopulation in this area is the lack of availability of affordable spay/neuter services within their community. The second would be the lack of public understanding on the benefits of sterilization. Thirdly, the lack of affordable resources and assistance for caretakers of feral cats in the area.

What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?

We polled a number of private vet practices within the area and found that the average price for female and male cat sterilization is \$262.00 and \$217.00 respectively. Many do not offer a reduced rate for feral cats. This is not acceptable in an area with 21% of the residents below the poverty level. The SNIP-it clinic will provide these services in an area that most needs it.

Florida Animal Friend is highly supportive of proposals that are focused on animal populations that are identified as substantial sources of dog or cat overpopulation rather than being diluted over too broad of a geographic area or diverse animal populations. The targeted area is rural, suburban and urban. There are feral cat colonies in commercial, residential and agricultural areas.

Every effort will be made to listen to and alleviate this concern. Last resort measures on relocation may be considered if all other options are exhausted. All feral cats will be ear-tipped and the micro-chip is available at cost. All m/c will have Protectors of Companion Animals listed as a second contact should the cat be brought into a vet office or Animal Services, we will be the second contact to return the cat to the colony, this saving more lives.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

We hope to sterilize 875 cats in the community. We hope to increase awareness of affordable spay/neuter services which will increase the number of services provided to animals in the targeted area in a 12 month period.

How does this program increase the number of sterilization surgeries above the existing baseline?

Since Osceola County does not currently have affordable services, the SNiP-it clinic will start from baseline and go up.

Methods

What criteria will you use to determine eligibility for your program?

Eligibility will be determined by matching the client address on government issued ID with the zip codes of the targeted area.

How will you advertise the program? Explain how the advertising will reach the target audience.

We will advertise on our Website and social media pages like Facebook and Twitter. We will also share the information with our supporting organizations like CARE Feline TNR, Cats Can, It's all about the cats and Osceola County Animal Services. We will have flyers for distribution at local retail stores like Pet Supermarket, Petco and PetSmart. We will send out email blasts to our members and followers.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Transportation barriers will be addressed on a one by one basis. If a localized area has multiple clients with the same need, a temporary transport system may be set up. There is a large Hispanic population within the targeted area. Educational materials will be available in Spanish and English to address this need. Every effort will be made to educate the public on the benefits of spay/neuter and ensure the success of this program.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Not at this time. If necessary, guidance from the Humane Alliance transport procedures will be used.

Pain medications are included with the service at no charge. Rabies vaccines are required if no proof of current vaccination can be provided by date of surgery. Ear-tipping is mandatory for feral cats (not kittens that are social) at no charge and not required for community cats. Microchips are available for \$5 for ferals and \$10 for community cats.

The SNiP-it clinic is following the Humane Alliance of NC's high volume spay/neuter clinic business model. Over 100 clinics have opened and are successful using there program. We are among the fortunate clinics to do the same.

Rabies vaccines are required if no proof is presented at time of surgery for \$10 payable by the client. Micro-chips are available for feral cats for \$5 and \$10 for community cats paid for by the client. Ear-tipping is mandatory for feral cats free of charge but optional for kittens that can be socialized for adoption.

Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

Rabies vaccines are required if no proof is presented at time of surgery for \$10 payable by the client. Micro-chips are available for feral cats for \$5 and \$10 for community cats paid for by the client. Ear-tipping is mandatory for feral cats free of charge but optional for kittens that can be socialized for adoption.

Community cat clients will pay \$25 toward the service. Feral cats in traps will be free of charge. Budget \$25 per community/owned cat x 750 cats = \$18,750 \$0 per feral cat x 125 = \$0
