Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the ability to carry out this program. Since its start in 2003, CATS-CAN, Inc. (CCI) has operated primarily as cat rescue and adoption group. We adopt 750-800 cats per year. CCI is also very involved in Trap-Neuter-Return through our volunteers and Board members. We also help cats with medical issues financially to enable owners retain their pets. CCI holds kitten classes to teach the community on how to foster bottle-baby kittens. CCI also conducts TNR training.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

Every cat we adopt out is sterilized before adoption using the adoption fees we charge. Many of the T-N-R cats are paid for by the volunteer trappers themselves. Some of the T-N-R cats are done under various grants. As you know, Florida in general has no shortage of feral cats and we are currently fixing as many as we can afford to do. With more funding resources we can sterilize more of the feral population.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area: Abandonment of pets, feral cat reproduction capability, warm climate allowing for more litters and survival of litters, affordability of sterilization, lack of education on spay/neuter, and lack of transportation are all parts of the puzzle to our overpopulation problem.

What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?

Two low-cost clinics in Seminole County are Pet Alliance and Spay N Save Animal Clinic. Both are excellent at helping sterilize affordably but to make an impact our T-N-R volunteers need help financially to do more.

Florida Animal Friend is highly supportive of proposals that are focused on animal populations that are identified as substantial sources of dog or cat overpopulation rather than being diluted over too broad of a geographic area or diverse animal populations. The zip code areas we have chosen include four cities in Seminole County, FL, and comprise an estimated square mileage of 134 sq.miles.

The criteria we are using comes from the Seminole County Animal Services statistics. These zip code areas are the four with the highest intake of cats to Seminole County Animal Services.

These four zip codes are primarily suburban and urban, residential and commercial.

Community cats will be cared for by the residents where the cats are living. Any feral colonies will have dedicated feeders. We already have multiple feral cat caretakers in Seminole County taking care of colonies.

We vaccinate all cats against rabies to keep that from becoming an issue with other cats or wildlife. We educate feeders not to leave food at night that might attract wildlife

We will talk with any resident who has an issue with outdoor cats and explain the importance and effect of T-N-R. If issues cannot be resolved we

Our volunteers have been working on T-N-R for years often at their own expense. Additional funding will help these volunteers do even more. Many of them spend more that one day a week trapping and transporting cats for sterilization. We have a very dedicated team.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

Our main objective to is decrease the high number of intakes of cats coming into Seminole County Animal Services from these four zip code areas. These four areas cover most of the communities with the highest number of residents living below the poverty level and where these funds will be most useful.

How does this program increase the number of sterilization surgeries above the existing baseline?

By specifically targeting these low income areas we can reach the population of cats that would not be sterilized otherwise. By helping with trapping, transport & recovery by volunteers we will reduce the number of cats being turned in to and being euthanized at animal services.

Methods

What criteria will you use to determine eligibility for your program?

Cats must be in the designated zip code areas. Caretakers need proof of low-income shown by any government assistance program they are under.

How will you advertise the program? Explain how the advertising will reach the target audience. Our greatest reach is through Facebook and our website as well as referals from our veterinarians. We will also post flyers in places such as community centers, laundromats, churches and at events.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles? We will supply transportation and recovery of cats when needed. We have volunteers who speak Spanish and can print flyers in English and Spanish.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Yes. Vounteers us personal vehicles and we loan traps out for safe capture and transport of cats. Our volunteers are experienced and we train all new trappers on safety. CATS-CAN holds mini-seminars on T-N-R practices.

Our sterilization will be performed by Spay N Save Animal Clinic through appointments or the walk-in services.

Rabies vaccine will be mandatory and will be covered by CATS-CAN, Inc. Ear notching is at no charge. Microchipping is at caretakers expense. We don't recommend FeLv or FIV testing unless cat appears ill and that will be covered either by caretaker or CATS-CAN if caretaker cannot afford.
