We have over 200 years of animal sheltering experience with existing staff. The director has over 42 years working with animals, 33 of which have been in animal sheltering.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

We are a Best Friends Community Cat program partner organizations which started in 2018 and ends in 2021. The majority of surgeries for that program are performed by a private veterinarian at our facility. She is paid \$50 per cat and the goal is 2500 cats per year.

This grant request is for Osceola County. We have other community cat programs in place including one funded by Best Friends Animal Society. However, that program is smaller, two staff, so they are limited by human resources. We are expanding our volunteer program to include thr participation to supplement existing efforts by individuals in our community and what can be accomplished through the Best Friends Program.

What is the criteria used for determining the target area(s) and/or eligibility for this program?

Community cats can be owned outside cats but can also include feral and free-roaming cats. Any caregiver or trapper for these groups of cats in Osceola County would be eligible.

Describe whether the targeted area is rural, suburban, or urban. Is it commercial, residential, agricultural, or a designated special land use?

Osceola County is still largely rural agricultural so efforts would be more concentrated in urban areas where resources for sustenance exist.

For TNR program, describe the ability to maintain lifelong care for remaining cats, commitment level of volunteers/organizations, etc.

We have spay the strays in Osceola County and they have worked on TNR for many years. Also, a local coalition formed just over a year ago works on trapping, neutering and returning cats from targeted areas in the County one day per month. Identified community cat colonies typically have multiple feeders who are willing and able to provide lifelong care to these animals but have a primary need for assistance with spay/neuter.

Do current city/county ordinances address TNR or free-roaming cats? Yes

Please explain what is allowed:

Community Cats are not considered owned. Leaving food out at night is prohibited. Feeding areas must be kept clean and free of debris. (NOTE: FAF will not fund any program this is inconsistent with local ordinances.)

Describe any effort to lessen the negative impact on local wildlife.

Through the Best Friends program, we offer deterrents to Osceola County residents to keep cats away from certain areas, bird baths and feeders, and also make an effort to ensure colonies are away from wildlife protection areas.

Describe efforts that will be made to mitigate current or potential nuisance issues.

We will continue to educate the public on the benefits of TNR, offer deterrents for keeping cats out of unwanted areas, work with feeders to make designated feeding areas as cat friendly as possible, and relocate cats when needed and opportunities arise.

The goal is to have funds to get another 500 community cats spayed/neutered. This effort combined with other programs in our community will work to drive down intact community cat populations which over time will result in fewer cats coming into the shelter, fewer cat related complaints, fewer cats destroying wildlife, etc.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

Our goal is to spay/neuter, vaccinated, and ear tip 500 community cats in Osceola County.

How does this program increase the number of sterilization surgeries above the existing baseline?

While we will likely perform some of these surgeries, the bulk of them will be performed at the SNIP-it clinic. Without this funding, they will not be able to accommodate individual feeders who come to them asking for help. Each year, collectively, we estimate that 7,500 cats are spayed/neuter in Osceola County. This additional 500 cats will be an increase of 7%.

Methods

What criteria will you use to determine eligibility for your program?

Cats must come from Osceola County and be considered community cats which can include feral, abandoned, and lost cats. Cats must have a person who is willing and able to provide continued care and oversight of the colony.

How will you advertise the program? Explain how the advertising will reach the target audience.

We will use social media, facebook and website, and paid advertising.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

We have volunteers in our community that have agreed to trap and transport cats for TNR. Best Friends has agreed to share their written materials with us and they are in English and Spanish.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Yes, community cats and often transported by volunteers in cargo vans or personal vans. Cats are confined in traps for transport and offloaded by volunteers and clinic personnel upon arrival to the location where s/n will occur. Transportation distances are short and animals are monitored during transport.

Rabies and FVRCP vaccines are included in the \$50 cost as is pain medication. Ear tipping is also included. If microchipping is requested, Osceola County Animal Services will pay the cost of the chip. Selection of what chip will be at OCAS discretion.

The Best Friends Community Cat program that is operated out of the Osceola County Animal services shelter will provide funding for community cat TNR and RTF, return to field, cats for the next two years. After two years, Osceola County will absorb the cost of the community cat program into our budget.
