RttR has created a spay/neuter program, Fix it Forward – Levy County. Currently we are assisting citizens on a case by case basis. Our VP, Sarah Podobinski, will be our lead on our Spay/Neuter projects. She has been actively involved in rescue for over 7 years. She holds a degree in business with a background in accounting. Sarah has a strong relationship with citizens in Levy County as she is an active member of the community and has live there nearly her entire life. Our board members have a total combined 50+ years of experience in rescue work, communicating with the public, have developed strong relationships with the community and advertisers, etc. Having received the FAF grant in 2017, we know have a better, working knowledge of processes that work.

**If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?**

We are currently providing spay neuter services on a limited basis, as funding becomes available. Funding comes from private donors, fundraisers and events. We are receiving more requests than we can fund at this time. Additional funding from the FAF Grant will allow us to increase the number of people we are able to help.

<b>Please explain if you believe your target area animal population is significantly different than above.</b> There are three Town/City run shelters in Levy County, Inglis, Williston and Chiefland. Their intake numbers are not included in the numbers provided by the county. Therefore the number of strays and euthanizations is actually higher. These shelters have very little to no exposure to the public. The return to owner/adoption rate is little to none as a lot of our residents are unaware that they even exists.	
<b>Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:</b> Levy County is a very rural, expansive area with low to middle class residents. Many animals are obtained solely for protection of homes and farms. Due to being a lower income area, many residents are unable to provide proper vetting or spay/neuter. The amount of free roaming/uncontained animals plays a huge role in the pet over population. A lot of residents cannot afford proper housing or containment for their animals. Levy County has an ordinance against free roaming animals, Sec 14-34, therefore a lot of 'stray' animals end up at animal control. On average, around 80% of dogs at animal control at any given time are pitbull type/large dog.	
<b>What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?</b> There are several private veterinary practice throughout Levy County, however due to income restrictions of residents, not everyone is able to utilize these services especially when spay/neuter fees are normally based on weight. Larger animals tend to be more expensive, so even middle income families have a difficult time paying such a large fee.

## Objectives

**What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?**

RttR hopes to reduce the amount of unwanted pets in our area. We are hoping to encourage people to alter their animals to prevent unwanted litters and free roaming animals. In return, decreasing the number of animals that enter animal control, surrendered to rescues or end up as strays.

**How does this program increase the number of sterilization surgeries above the existing baseline?**

The grant will help us continue with our current spay neuter program and hope to greatly reduce the number of unaltered animals in Levy and surrounding counties. Currently, on average, we are able to provide spay/neuter services to about 15-20 animals, costing us around \$80-120 per animal. With help from the FAF Grant, we can increase that number greatly. We have found that offering these services for 'free' to residents, increases the likelihood of people actually using them. There are a normally services for people who are 'low income' but we feel this excludes the middle class, people who cannot get assistance but also cannot afford to pay a private vet for spay neuter services. We would like to reach families across all ranges.

## Methods

**What criteria will you use to determine eligibility for your program?**

Any "pitbull" type breed and or dogs over 40 pounds.

**How will you advertise the program? Explain how the advertising will reach the target audience.**

We have a large social media presence as well as relationships with other local area rescues, business and media outlets. With much of our population low income, we also rely on word of mouth, which we have learned over the past year, spreads far and fast. We also take advantage on the different media sources such as print, radio and television.

**How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?**

Our organization is comprised of many different backgrounds and ethnicities. We have a large span of age as well. We are able to communicate across numerous boundaries to get the message out there.

If animals are unable to be transported by their owners, transportation arranges will be made. We have a network of reliable, experienced volunteer animal transporters. Animals will be confined to a secure crate during transport.

We will target low to middle income families and those who are s/n resistant in hopes that offering them free services will encourage them to take advantage of the service. Levy County is in desperate need of reducing the pet population in order to take the strain off of the county facility and the surrounding rescue groups.
