TLC PetSnip, Inc. is a high volume spay/neuter organization with three locations and has performed close to 50,000 procedures since opening in 2013. We are an ASPCA Spay/Neuter Alliance mentored organization with ASPCA Spay/Neuter Alliance trained staff and surgeons. This grant application is specifically written for TLC PetSnip-Ocala, which has provided over 10,000 spays and neuters since opening November 2018. The persons in charge of this program will be Lisa Gray, C.V.T., and Terry Sandlak. Lisa will be monitoring the program remotely from the Lakeland office and Terry will be running the program at the Ocala office.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

TLC PetSnip, Inc. currently uses earned income from spay/neuter and wellness services. TLC PetSnip provides free and discounted service with the assistance of the Humane Society of Marion County on a monthly basis. Additional funding resources are necessary because of the high need in Marion County. The programs that are offered as a result of the funding from the HSMC are usually fully booked on the same day that they are announced. The additional funding from the Florida Animal Friend will be used in conjunction with the earned income and the funding from HSMC.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area: The most substantial source of pet overpopulation is the lack of affordable spay/neuter resources in the county.	
What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs? Currently, the general practitioners, the Humane Society of Marion County, and Animal Services of Marion County offer spay/neuter services. These resources are insufficient because they are unable to perform high-volume and high-quality services. The percent of residents that live below the poverty level is 15.1%. There is a large majority of residents that have pets that need to be sterilized and they are financially unable to have that done. The HSMC and MCAS both have long waiting lists for their services.

TNR Managed Colony Feral Cat Program/Community Cats (Free-Roaming and/or Owned) Program

Marion County is 1,584 square miles and is a widely rural county. We plan to systematically target zip codes 34470, 34471, 34474, and 34473.

What is the criteria used for determining the target area(s) and/or eligibility for this program?

We will ask residents to provide proof of residency for this program. We will require a driver's license or utility bill with their name and address on it to qualify.

Describe whether the targeted area is rural, suburban, or urban. Is it commercial, residential, agricultural, or a designated special land use?

The targeted area is primarily rural and agricultural. Ocala has one of the largest populations of horse breeding ranches in the state.

The cats that will be part of this program will have caretakers that have received training from the TLC PetSnip-Ocala feral cat trapper. TLC PetSnip has an active training program for volunteers and colony caretakers.

Marion County Animal Services allows for feral cats to be sterilized and then returned to the field with a colony caretaker.

We will be working with colony caretakers to make sure that colonies are not located in any type of wildlife preserve area or area that wildlife could potentially be negatively impacted.

Describe efforts that will be made to mitigate current or potential nuisance issues.

TLC PetSnip employs a part-time feral cat trapper that will be assisting with any nuisance calls. We will provide additional resources and educational materials to people the colony caretakers. Our part-time feral cat trapper has a cell phone paid for by TLC PetSnip to ensure that she is easily accessible.

TLC PetSnip-Ocala provided 1313 feral cat sterilizations during the last fiscal year. In that time we have learned how to fully manage a feral cat program. TLC PetSnip-Ocala has a holding area that is used only for feral cats, a feral cat trapper, and an experienced and dedicated staff. We are working closely with the municipal shelters and private shelters to ensure that we are actively targeting the areas with the highest need.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

The goal for this program us to provide spay/neuter services to feral/community cats, Pitbulls, and large breed dogs that are owned by financially restricted clients and persons that are actively participating in TNVR efforts. We plan to provide sterilization services to 700 feral/community cats and 150 large breeds and Pitbull type of dogs. The 850 sterilizations provided by this funding will prevent thousands of dogs and cats to be born unwanted.

How does this program increase the number of sterilization surgeries above the existing baseline?

This program will increase the number of sterilization procedures by increasing access to veterinary care to the target population.

Methods

What criteria will you use to determine eligibility for your program?

We will be utilizing proof of income from clients to be eligible for this program. We will also require proof of residency in the form of a driver's license or utility bill for the targeted zip codes.

How will you advertise the program? Explain how the advertising will reach the target audience.

We will be advertising this program through social media, our website, and flyers. We have a social media following of over 20,000 and our website has regular traffic. The flyers will be designed in both English and Spanish and distributed to local businesses and placed on community bulletin boards.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Barriers that may be presented during this program will be addressed individually. We will utilize a bilingual volunteer and volunteers that have worked within the targeted area during other programs. We will make certain that the flyers have visual cues to assist with anyone that may be illiterate.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

This program does not directly provide transportation to clients. Clients will be encouraged to provide their own transportation; however, if a client is in need of transportation we will utilize our transportation team. The TLC PetSnip, Inc. transportation team will use one of the TLC PetSnip transportation vehicles. We own an RV and cargo van that have both been with measures to ensure the safe transportation of dogs and cats.

We have an in-house ASPCA Spay/Neuter Alliance trained surgeon to perform the procedures.

TLC PetSnip-Ocala was opened in November of 2018 after being approached earlier in the year by County Commissioner Kathy Bryant. Since opening we have built relationships with rescue groups, private shelters, and the municipal shelter. Our relationships have allowed TLC PetSnip, Inc. to grow and build credibility in Marion County. Since we opened our HQHVSN facility in Marion County we have provided over 10,000 surgeries.
