We are not, officially, an adoption facility, but we do care for and eventually place cruelty, neglect, and abandonment cases. All pets are sterilized prior to adoption.

Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the ability to carry out this program.

Since transitioning from a no-kill shelter to the area's first low cost clinic, Clay Humane has been on the frontline battling pet overpopulation in our community. In 2013, we launched a free cat spay/neuter program that saw the sterilization of over 30,000 cats, both owned and feral. Although COVID forced an end to this popular program, we intend to relaunch a new sterilization program for both cats and dogs this summer.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

Clay Humane's free cat sterilization program is the most recognized spay and neuter effort in our community. Because we were the only organization to offer completely free spays and neuters without restrictions and even without outside funding, the demand for appointments was great. COVID created obstacles to continuing this program in 2021, both physically and financially. To help meet the needs of cat owners and caregivers in our area, we increased our support staff and added an additional veterinarian, tripled the number of cat surgeries we performed each day, and designated Tuesdays as "Feral Day" on which no appointment is required (and as many as 75 feral cat spays and neuters are performed). Since launching the program, we have sterilized 31,384 in total, including over 9,000 feral cats— as many as were sterilized in the ten previous years total – preventing hundreds of thousands of unwanted births and, in turn, countless senseless deaths on streets and in shelters.

Although we offer the free service to cat owners/ feral caregivers anywhere, priority scheduling consideration is given to Clay County families and colonies. Our efforts are evident in the declining shelter cat intake numbers. In 2013, at the time of the program's inception, Clay County Animal Care and Control took in 2526 cats. In 2014, the shelter's cat intake dropped to 1942 and continued to drop in 2015 to a total cat intake of 1499. 2018 saw the lowest intake number (excluding TNR numbers) of less than 800 cats. This incredible decrease represents the most significant in shelter history, particularly as it is coupled with unprecedented human population growth in our community. Sadly, COVID created a set back that we hope to overcome in 2021-2022. We will expand this far-reaching program and plan to add free pit bull sterilizations to our efforts, as well. Despite our inspiring cat sterilization effects, many dogs still find their way to our area shelters. Most are pit bulls or pitbull mixes and hounds/ mixes who regularly are unsterilized and go unclaimed. It is our goal to direct efforts to reduce these numbers, as well.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area: Our community is a mostly rural area comprised of low income families. Few affordable sterilization programs exist in the large target area that are capable of serving those whose budgets do not allow for even reduced rates. Our programs focus on these populations, feral colonies, and the pit bulls/ hounds who disproportionately fill our shelters.	
What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs? Private veterinary clinics offer sterilizations, but at costs outside of many pet owners' budgets. Other low cost options exist, but applications, distance to the site, and qualifying create obstacles to successful programs.

TNR Managed Colony Feral Cat Program/Community Cats (Free-Roaming and/or Owned) Program

Define the precise boundaries of the colony or targeted area, including estimate of square miles.

Clay County feral populations are our primary focus, but we extend our free feral sterilizations to colony caregivers in surrounding counties, as well. Currently, we are focused on regaining control over colonies that were able to grow during the 2020 non-essential surgery restrictions. We estimate approximately 1400 feral cats will be sterilized from 6 colonies in Clay County, 3 in Putnam County, and 3 colonies in Bradford County.

What is the criteria used for determining the target area(s) and/or eligibility for this program?

We work with area colony caregivers to identify sterilization needs. We have no requirements for free feral sterilizations - the caregivers trap and transport.

Describe whether the targeted area is rural, suburban, or urban. Is it commercial, residential, agricultural, or a designated special land use?

Targeted populations for this request exist primarily in rural areas with the exception of one in the town of Orange Park that is in a commercial area.

The colonies we target are identified by caregivers that we have worked with since the programs' inception. They are dedicated to caring for these colonies.

Please explain what is allowed:

Following lengthy debates before our County Commission, the combined efforts of area animal welfare advocates prevented the mass trapping and euthanasia of feral colony cats. TNR measures were approved for identified and future managed colonies with Clay Humane taking the lead on these efforts with our county's animal services.

In all county's that we assist with feline spay and neuter efforts, we are supported by the animal control services, governing bodies, rescues, and advocates.

Describe any effort to lessen the negative impact on local wildlife.

As licensed wildlife rehabilitators, we have seen first hand the negative impact roaming cats can have on wildlife. As such, it is our goal to eliminate through adoption/ relocation programs cat colonies existing on public wooded lands first. These colonies remain a consistent priority as our efforts to protect wildlife helps foster goodwill between wildlife and feral advocates.

Describe efforts that will be made to mitigate current or potential nuisance issues.

Over the years we have been called upon to assist with colonies on commercial lands that were facing euthanasia due to nuisance complaints. In many cases, Clay Humane performed free sterilization of the cats, provided colony management education, assisted with rehoming adoptable cats and, on occasion, relocated to private property, as needed.

In its 8th year, our free feral cat sterilization program is essential. Covid restrictions caused us to lose some ground in our battle against the overpopulation of these colonies, but we are committed to regaining the upper hand in the fight. We are also, still focused on specific dog populations that are most common in our shelters.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

Our goal since transitioning to a low cost spay and neuter clinic in 1991 has always been to reduce/ eliminate the senseless euthanasia of healthy animals in our community. In conjunction with our county's TNR efforts, we expect to meet this goal in the near future. With funding, we will sterilize 1400 identified feral cats and 125 bully breeds and/or hounds that are most common in our area shelters.

How does this program increase the number of sterilization surgeries above the existing baseline?

COVID created a significant back up of cat spays and neuters. Funds normally directed to the program were redirected to ensure our clinic remained open and functioning during the pandemic. It will take time for us to return to the pre-pandemic numbers and funding, but we will get there. This year, we are focused primarily on feral populations and the breeds of dogs who most fill our shelters. Funding support will help us recover from pandemic shortages and will help breathe life back into our feral cat program.

Methods

What criteria will you use to determine eligibility for your program?

There are no eligibility requirements aside from identified colonies via caregivers or animal control agencies. Anyone willing to trap and transport feral cats are eligible to receive free sterilization through this program.

How will you advertise the program? Explain how the advertising will reach the target audience.

Our cat program is very popular. Flyers, door hangers, and refrigerator magnets are available to many area county animal organizations and dispersed to the public as needed. Our website and social media accounts advertise our services, as well.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Through cooperative efforts with area shelters, rescue groups, volunteers, colony caregivers, advocates, media outlets and local business owners, we are better able to identify those in need. Together, we are able to trap, transport, release and control the growth of colonies and, in turn, shelter numbers. Our greatest struggle has been, and will likely remain, the stigma of neutering pit bulls in our, largely, rural community.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

The program does not involve transportation by staff, but relies on volunteers and private citizens to transport.

Veterinary Services

What arrangements have you made with veterinarians to perform the surgeries?

Clay Humane has operated a full service low cost veterinary clinic since 1991. We have 4 full time and 4 relief veterinarians committed to our mission of a no-kill community through spay and neuter efforts.

Every Tuesday, Clay Humane performs up to 75 free feral spays and neuters including ear tipping, rabies vaccination, and pain medication. Funding would allow for 1400 feral cat sterilizations (840 females, 560 males) plus 125 dogs (75 females, 50 males).

Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

Each year, our vendors generously donate doses of vaccines and microchips to help offset costs associated with our sterilization programs. We hope this remains the case, but are prepared to absorb these additional costs should it be necessary. Miscellaneous vaccinations, tests, etc are at owners' or caregivers' expense.

Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

Allocated funds generated via our wellness clinic, private donations, "spay it forward" contributions, and fundraising events through the year help fund our sterilization program. Because of COVID restrictions, a decline in contributions, and the inability to hold our normal fundraiser events, the program numbers have been significantly reduced. We have budgeted to perform 1500 free cat sterilizations and funding would allow us to nearly double our efforts for cats and provide support to the shelters with dog sterilizations.

As noted, our cat sterilization program is supported by revenues generated through our wellness clinic and through fundraising efforts. We expect to return to more normal fundraising efforts within the next 12 months and to be able to redirect budgeted funds to increase the program again at that time.
