We have been able to hire one new person to fill the two recently vacated positions by Best Friends. this person, along with our Officers and volunteers will continue the community cat program work that has already been started in Osceola County.

Community cats are not considered owned, however, feeders and caregivers are prohibited from feeding at night, leaving food out, allowing feeding areas to become cluttered or unsanitary, etc.

(NOTE: FAF will not fund any program this is inconsistent with local ordinances.)

Describe any effort to lessen the negative impact on local wildlife.

We do not approve colonies that are situated close to wildlife sanctuaries. We also encourage feeders to plant catnip, offer hiding places, etc. in areas where they are fed to minimize roaming.

Describe efforts that will be made to mitigate current or potential nuisance issues.

We provide deterrents to citizens who have concerns about cats. most problem behaviors are abated via spay/neuter. We also bring young kittens into the foster program and send them out for adoption rather than leaving them in the community.

Will the cats be ear-tipped? Yes Will the cats be microchipped? No

Only cats that appear healthy and are old enough to receive a rabies vaccination are eligible. Also, they will be giving an FVRCP vaccine. Unhealthy cats will either be treated then TNRd or euthanized depending on the seriousness of the condition. Pain meds are given at the time of surgery.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

Continue to get as many community cats spayed/neutered, vaccinated, and returned as possible as well as given younger kittens a chance for adoption thereby immediately reducing the number of cats in a given area. To get as many outdoor cats rabies vaccinated as possible.

How does this program increase the number of sterilization surgeries above the existing baseline?

It will increase it by 500 animals at \$50.00 per surgery.

The new person we hired is bilingual and did TNR in Puerto Rico. We have a large Hispanic population in Osceola County and feel that she will be able to help overcome cultural obstacles due to her experience and background She speaks and writes english and Spanish very clearly.

Yes, our new Community Cat Coordinator, Officers, and certain designated volunteers will handle the transporting of community cats.

All cats are rables and FVRCP vaccinated. They are given pain meds at the time of surgery. Examinations are not usually possible on community cats, although if they are, an examination would be conducted. All cats are ear tipped as the universal sign of being spayed/neutered.
