Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the ability to carry out this program.

Our organization has been transporting animals to be sterilized since October of 2017. We currently drive 50 to 75 animals every other Tuesday to the clinic 2.5 hours away. We have been consistent and keep our van up to date on maintenance and other routine care in order to continue providing this service until our clinic is built. We have a new van, which arrived last month, nearing completion of the interior and exterior design which will be primarily used for this same service. Our spay/neuter transport program is coordinated by multiple individuals and, though the volunteers in charge of the program have rotated, the roles have been the same; and always filled. Our treasurer maintains the number of clients related to the grant amount and has a team working under him who keeps up to date data tracking. He then communicates frequently with the Transport Team to let us all know our status as we go. We have 5 years of documentation and volunteer hours to prove our ability to continue carrying out this program and find this to be our primary program.

If you currently have a program for sterilization of cats and/or dogs, describe your current level of funding and productivity and why additional resources are needed?

Our clients pay for the sterilization of their pets and community cats. We have monthly donors who cover the cost for our rescue animals to be sterilized. The issue we are facing is with the increase in prices at the clinic we use. Though the cost is still low, the dollar amount is cutting into

the pockets of our cat caregivers who mostly pay for more than 5 to 10 cats. A simple increase of \$5 per animal could be an extra \$50 for a person who was short on funds to begin with. We need to continue keeping the cost as low as possible so we can sterilize as many animals as possible and keep them from reproducing. We already chose not to increase our community cat prices this year, even though the clinic we use did. We opted to raise the owned animal prices the same amount our clinic did and try to keep the cat cost down. We are doing what we can, but this price break will likely hurt our organization needs while we are raising funds to build a clinic here, locally.

Florida Animal Friend grants are for low-cost and/or no-cost spay/neuter programs; If you currently have such a program, please describe

We have a transportation program to the nearest low cost clinic five counties east of us. Though we are in the process of building our own clinic, this is the option we have taken for the past 5 years, every other Tuesday. To date, we have taken over 5,000 animals to be sterilized.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area: Local breeders not being controlled, hunting dogs/clubs allowing over breeding and releases after season, and general mindset of cat caretakers and owners who are unaware of the benefits to spay/neuter.	
What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs? We provide a transportation service every other week to a clinic 2.5 hours away and hold around 60 animals on each trip, for the general public. The local shelter is only able to provide spay and neuter to animals they own and in their care. There is one other small transportation service to a clinic in Mississippi for cats which takes about 10 to 20 twice a month.

We have excellent caretakers in our area who provide food and daily care and even set up Facebook accounts to coordinate care when they move or go on trips. They just focus so much on the feeding that they can't afford the spay/neuter.

We strongly encourage feeding times to be short and twice a day with removal of trash. Cats who are in a dangerous area or who are a danger to others are relocated if possible. If not, many caretakers build catios or try to bring them inside.

We always take complaint calls and explain what we can do to help.

We will promote this grant and encourage more cat caretakers to use our service even though the clinic prices are increasing. We are trying to keep the cost low so everyone can use our services and we can continue to build our clinic locally.

Objectives

We will fix a minimum of 766 cats in 12 months with these funds

How does this program increase the number of sterilization surgeries above the existing baseline?

We are always increasing the number of cats we take to get fixed and work with the clinic to try and increase the number of surgeries whenever possible

Methods

What criteria will you use to determine eligibility for your program?

We believe that anyone who has a pet should be eligible to get them fixed at a reduced cost in order for the caretaker to focus on the daily needs and extended medical care throughout the life of the pet. Anyone who cares about their cat will be eligible to use this service.

How will you advertise the program? Explain how the advertising will reach the target audience.

We will advertise on Instagram, Facebook, Twitter, Tumblr, in the 4 local newspapers, Channel 3 News, and by word of mouth

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

We offer the transportation currently and have a new van coming very soon (it's in production). We use email/text/phone calls to communicate with our guest and promote our services in the shelters, churches, and pet stores too.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

We transport all of the animals to the clinic. The guest signs a waiver and gets clear instructions for the type and size of carriers. We identify every carrier with tape and an "SRC" clip while confirming the animal is exactly who the caretaker says. We add extra zip ties to every carrier and crate.

We also bungee down the carriers and have 3 people who check the security of the van contents. The driver and van are fully insured. We also have friends at another organization on the way who would gladly send out their vans to assist, should we have any breakdowns along the way.

We are requesting funding to offset the cat fees for sterilization and rabies. Rabies vaccine is \$16 and we're asking for grant funds of \$1 for each

cat. The outdoor cat price would be \$25 and we are requesting the other \$25 from FAF. The rabies price is included. Total cost to client would be \$55 for indoor cats and \$25 for outdoor cats and both include rabies.

Escarosa Trap/Neuter/Return	This is a Facebook group who assist the community with trapping and fixing cats. They share our page often and guide caretakers to help get their cats sterilized.
Gulf Breeze News	This is a newspaper who runs stories about our spay/neuter specials and other events to help draw in media attention in the south end of our county.
Panhandle Animal Welfare Society	This is the animal control agency in the neighboring county who supports us and sends anyone our way who may use our transportation service versus shelter surrendering.
Santa Rosa County Animal Services	We work closely with our local shelter to assist overflow from their normal surgery schedule for in house animals. They also contact us should an owner surrender be avoided with veterinary assistance.
Santa Rosa Press Gazette	This newspaper shares our sterilization specials for animals and helps market the grantors who make it possible.
Save Our Cats and Kittens	This group currently does their own transportation of cats but refers out to us should their followers need extra resources for sterilization.
WEAR 3	This is the local television station that markets our organization whenever we have been spay/neuter trips happening and when we run specials to helped the underserved communities.

Our team advertises our transportation service three weeks prior to a trip and routinely drives every other Tuesday. Our Treasurer and his team will have the target numbers necessary to reach these goals and will keep us up to date within 48 hours after each trip. Should we get to the 12 month cutoff date and have a large number left to sterilize to achieve our goals, we will work with the clinic to run some mass spay trips to catch up and assist the community in using these funds.

We have applied for other grants and will always continue to apply for them in order to keep the cost low for our clients. We have yet to receive word on the other funding sources but this program has been running for 5 years now and will not end. We are building a clinic here locally in order to increase the number of clients we serve.
