ARC's Program Manager is responsible for organizing and administering the six programs which are funded by ARC donations and grants. One program, the Transport Program enables low-income families to receive transport and spay/neuter services at ARC for only \$25. Oversight for this program and others are provided by our Medical Director who assesses capacity and staffing, a Clinic Manager and an Executive Director. All program income, expenditures and impact are reviewed weekly by ARC's Comptroller and monthly by the Finance Committee and Board. We have the staffing and capacity to expand this program, especially since we are going to begin construction on an expansion to the clinic. We will have four surgical tables, two full-time vets, a large feral room and a resource center where patient families can receive information and education about veterinary care.

We are a low and in some instances, no cost spay/neuter program. Sixty percent of our operations are funded by donations and grants which allows ARC to keep its rates affordable. The most a patient will pay for a spay package for a non-high risk female dog is \$170. This price includes vaccines, a microchip, nail trim, e-collar and medication. **Number of animals sterilized in that program in the past year: Cats:** 2974 **Dogs:** 2981

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

ARC will provide low cost spay/neuter surgeries to 264 pets of low income families from DeSoto and Charlotte counties.

How does this program increase the number of sterilization surgeries above the existing baseline?

Currently, 65% of the families from these counties and others report in ARC's customer surveys that they would not sterilize their pets due to surgical expense. ARC currently uses donations to fund surgeries for the pets of low income families from DeSoto and Charlotte County but these funds are limited and therefore there are still families who need financial assistance for spay/neuter.

Methods

What criteria will you use to determine eligibility for your program?

ARC will request that pet owners provide proof of low income or represent that they do not have the resources to provide essential veterinary care for their pets.

How will you advertise the program? Explain how the advertising will reach the target audience.

ARC has over 10,000 followers on social media. We will use Facebook and Instagram to announce the grant as well as make appearances on local media. We will also send out press releases. ARC will also collaborate with local Animal Services to publicize the funding.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

ARC provides transport to Desoto and Charlotte counties, picking animals up and dropping them off after surgery. Families who use the transport are only charged \$25 for this service. We employ 2 Spanish-speaking technicians and offer instructions and appointment forms in Spanish. We recently used Google Translate with a family who emigrated recently to the United States from Ukraine.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

For residents of Desoto, Charlotte and Manatee Counties who do not have transportation, ARC has a transport van that is fully insured and capable of transporting 20 animals safely. Our staff maintain and drive the transport. They are trained using ARC's Transport Protocols. All families who use the van and come to ARC for care must sign consent forms and when necessary, high risk waivers.

Veterinary Services

What arrangements have you made with veterinarians to perform the surgeries?

ARC employs a full-time Medical Director who has been performing high volume spay/neuter surgeries since she was licensed in 2019. In addition to the Medical Director, ARC has a part-time associate vet who can assist with surgeries. We also have access to 4 relief vets who perform high volume surgeries, including on feral days where up to 80 surgeries can be performed by two vets.



Access to high quality spay/neuter and veterinary care is critical in Charlotte and Desoto counties due to the limited resources. ARC has the means and capacity to spay/neuter large numbers of animals from those counties. Depending on size, gender and species, ARC's veterinary team can perform on average, 30 surgeries a day.

Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

True cost of surgery for 265 animals (based on \$144/surgery true cost estimate) - \$38,160. Estimates of dogs/cats targeted based on previous 2 years' averages of patients - 23% female dogs, 20% male dogs, 32% female cats and 25% male cats. The services which would not be paid for by this grant will be funded through private donations, corporate gifts and other grants.

Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

ARC's operations are heavily subsidized as surgical costs far exceed the rates charged to patient families and the 55 rescue organizations we serve. We use our website to target donations for our programs, apply for various grants and host fundraising events to raise funds to support our mission. We also allocate monies in our annual budget to apply to programs. Our total support and revenue in 2022 was \$1,351.193.

We will fund this program for DeSoto and Charlotte counties with local grants from community foundations as well as individual and corporate donations. We also anticipate growth in gifts by implementing a legacy giving program. Also, while the costs of operating the clinic are high and we rely on donations and grant funding to keep our rates affordable, ARC and its programs are sustainable due to the income generated from the high volume of surgeries performed and the number of wellness appointments which generates income from vaccines, prevention and heartworm tests. ARC's leadership team, Finance Committee and Board of Directors also ensure that ARC 's finances are managed prudently and that donations and funding are stewarded.
