Our Foundation has been distributing s/n vouchers for dogs and cats in need since 2007. We had expanded to working with other organizations to transport to a low-cost clinic until opening Tally Spay in 2021, our own low-cost s/n clinic. We performed s/n surgeries for 7 months and then lost our only veterinarian. In Feb. 2023, we have re-opened 2 days/week. We just hired a full-time veterinarian that will start June 5th, allowing us to perform surgeries 4 days/week again. Between the vouchers and our clinic, we will have no problem serving the public and rescue groups. We will continue providing vouchers as well, partnering with other nearby low-cost clinics.

Florida Animal Friend grants are for low-cost and/or no-cost spay/neuter programs; If you currently have such a program, please describe

During the 7 months Tally Spay was open, we were very successful doing s/n surgeries. We are part of the ASPCA S/N Alliance program and received training in Asheville and had team from the ASPCA come to our clinic for a week. Our clinic is funded via low-cost surgeries, grants and \$65,000 annually from our budget. Grant resources allow us to provide no-cost surgeries to targeted areas that are much in need.

Describe the specific target animal population(s)

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

The target area for the grant was chosen to decrease the number of intakes at Tallahassee Animal Services (shelter) and reduce pet-overpopulation. We have been successful in offering s/n vouchers as part of our HOPES program in partnership with the shelter to keep animals from being surrendered. Additionally, we started a Community Cat Trap program where we have loaner traps for good Samaritan's to trap and return, instead of bringing the cats to the shelter. We plan to divert and alter a minimum of 1,000 cats that otherwise would have ended up at the shelter.

How does this program increase the number of sterilization surgeries above the existing baseline?

We have proven that with Tally Spay, we can significantly increase the number of surgeries in our community. Having this low-cost option allows us to do many more surgeries 3:1,

instead of using higher cost vet clinics. Unfortunately, the public, rescue and animal welfare organizations are starting to see prices with private clinics rising, becoming out of reach for too many. Between our voucher program and Tally Spay, we were able to do 2,753 surgeries last FY. With the hiring of an additional veterinarian we expect by next year to be able to provide at least 5,000 surgeries.

Methods

What criteria will you use to determine eligibility for your program?

One of three criteria: (1) Eligibility will be geographic, based on heat density map, where residents must live in Leon County (South of I-10 and West of Capital Circle East, or (2) identified by Tallahassee Animal Services or Animal Control as a person in need, to keep the animal from an intake at the shelter and/or to make it possible for the spay/neuter to occur, or (3) a request to spay/neuter through our Community Cat trap loaner program.

How will you advertise the program? Explain how the advertising will reach the target audience.

ASF plans to advertise through social media (both our ASF and Tally Spay social media pages), through our local animal welfare network organized by County Animal Control, through both City/County Animal Control and our local shelter, yard signs, flyers, mailings, press releases and community centers in our target area.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

We believe our location is prime for those who may have these barriers. Tally Spay is located on a high traffic road/intersection in the 32304 zip code - West side of town. This area zip code has the highest poverty level in the State. We will continue to cover surgeries done at at the two other low-cost clinics which are northeast and central to Tallahassee.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

For the most part, no. On occasion, Animal Control may choose to transport an animal to Tally Spay.

Veterinary Services

What arrangements have you made with veterinarians to perform the surgeries?

In addition to using our Tally Spay clinic, we plan to continue to use the two low-cost clinics that have been a part of our Animal Birth Control program. Both offer discounted rates to ASF. We will continue to have partner agreements in place with local vet clinics for services as needed.

ASF, with a partnership grant from Be The Solution, will incur the expense for rabies vaccine and any other additional expense as needed. Clients will have the option to pay for additional services at the time of surgery.

Is this a voucher program? Yes

If so, how will you assure utilization of the program?

We have a process in place to check compliance under our current program that will continue to be followed. We review invoices, keep in contact with our vets and receive the completed vouchers with backup documentation. This allows us to see the results, redemption rates and follow up with clients. At Tally Spay, we use ClinicHQ for tracking and reporting.

For your voucher program, how have you determined the capacity of the veterinarians listed above to handle the projected capacity?

With Tally Spay and the other two veterinary clinics listed, we will have more than enough capacity for this program. Additionally, we continue to have good relationships with our local veterinary clinics that we continue to use for other services.

Will you have the ability to report the number of vouchers issued and the number redeemed for spay/neuter surgeries?

Yes! We have a database we have used since the inception of the program that we started years ago. We currently track every voucher given out, dates, vets used, cost, animal and client information etc. This allows us to calculate redemption rates and allows for follow up as needed. We will use this in conjunction with ClinicHQ.

Be the Solution, Inc. (BTS)	ASF continues to have a long-standing partnership with BTS. BTS will cover the cost of rabies vaccines for those animals that need one and receive a surgery through the FAF grant funded program.
City of Tallahassee Animal Services	Tallahassee Animal Services will promote the program as part of the Pet Retention program and for good Samaritan's participating in the rehoming program. They will also be made available to those in need of spay/neuter services for their pets. Animal Control will use our vouchers as an educational tool when out in the field doing community outreach. They will also identify areas/individuals in need that would otherwise be unable to afford S/N surgery for their pets.
Leon County Animal Control	Leon County Animal Control has agreed to coordinate events combined with other needs - such as pet food giveaway in the underserved areas in our community. They will use the vouchers as a tool to educate about s/n and provide the community with a free service. They will also identify areas/individuals in need that would otherwise not be able to alter their animal.

Other Information

We are excited to have Tally Spay back open and expand this much needed service to our community. We continue to see a great need in our community and with rising costs we worry that pets will not get altered, negatively effecting shelter intakes and pet-overpopulation. This grant will allow us to further the mission. We continue to have strong partnerships with the local animal welfare groups: It's Meow or Never, Leon County Humane Society, Feline Advocates of Leon County and Big Dog Rescue to name a few.

Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

BTS will cover the costs of rabies vaccines, as needed. ASF will cover the costs of pain meds, fluids, microchips (to owned animals) and other costs as deemed necessary on an individual basis. Ear notching included at no charge for community cats.

Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

ASF's top program continues to be spay/neuter. ASF has committed \$65,000 annually to fund surgeries at our Tally Spay clinic. We have several fundraisers (Capital Campaign and Honor Wall at our clinic) in addition to other annual events for fundraising. Revenue from surgeries and other services will offset clinic costs and allow us to perform low-cost surgeries outside of no-cost surgeries through grants received.

What percent of the total cost of the program would this projected grant cover?
