The Animal Welfare League of Charlotte County (AWL) is a 501(c)3 organization with a solid commitment to saving lives. In 2021 we saved the lives of 3,123 homeless pets. By holding the county's Animal Control contract, we cannot be selective on intake. Yet, we still maintain a 96.24% live release rate. We do not euthanize any animal with a treatable disease. Instead, we diagnose and treat them, educate the public about the animals' unique needs, and prepare them for adoption. Our newly established H.E.L.P. program provides low-cost spay and neuter to those who qualify. Our Wellness Wagon serves the homeless and low-income families in Charlotte County. We extend our reach beyond Charlotte County to assist municipal shelters in producing more significant live outcomes, including Sarasota, Manatee, DeSoto, Highlands, Hillsborough, and Polk Counties. As an approved rescue partner of H.S.U.S. and the A.S.P.C.A., we assist in large-scale natural disasters and cruelty cases. The AWL medical clinic is the only free or reduced-cost animal hospital in Charlotte County. Through serving Veterans and homeless and low-income families through our outreach programs, the AWL sees animals with unique and sometimes severe needs. Our success rate is impressive, losing less than 2% of animals in the clinic's care. The AWL has a full-time licensed veterinarian and two full-time veterinarian technicians.

The "Help End Local Pet-overpopulation" program (H.E.L.P.) provides low-cost sterilization for pets of Charlotte County residents. Pet overpopulation contributes to pet homelessness, neglect, and abuse. Our mission with this program is to decrease pet overpopulation in our community. To qualify, the client must reside in Charlotte County and receive assistance from at least one of the county's assistance programs like food stamps, disability, Medicaid, or qualify as a Disabled American Veteran.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

We intend to use funds from this grant to accomplish two critical objectives. First, we want to ensure our H.E.L.P. program reaches the most qualified households. We intend to do this by using social media and other forms of advertising to promote this program and to increase its use by 15% within the Charlotte County community. This will be accomplished using resources at the Charlotte County Homeless Coalition, like providing promotional material at their twice-weekly food pantry distribution and through the Wellness Wagon. Second, we will increase our outreach to accomplish more T/N/R spays and neuters of community cats through our collaboration with the DeSoto County Animal Shelter and the Charlotte County Homeless Coalition. By working with both agencies, we expect our ability to reduce the community cat population by at least 10% over two years. Through other granting sources, the AWL acquired small mammal dens to assist with handling feral cats through capturing and surgery before re-releasing them to their known habitat.

How does this program increase the number of sterilization surgeries above the existing baseline?

This program, as outlined above, will increase the number of sterilization surgeries by a minimum of 15% over our current capacity.

Methods

What criteria will you use to determine eligibility for your program?

To qualify, the client must reside in Charlotte County and receive assistance from at least one of the county's assistance programs like food stamps, disability, Medicaid, or qualify as a Disabled American Veteran.

How will you advertise the program? Explain how the advertising will reach the target audience.

The program will be advertised through our two collaborating partners- the Charlotte County Homeless Coalition and the DeSoto County Animal Shelter. The Wellness Wagon, which visits the Homeless Coalition twice monthly, will share information with its clients about the availability of our low-cost spay/neuter services. Information will be shared with Food pantry clients at the Homeless Coalition. The food pantry is offered twice every week to more than 1,200 households every week. Facebook and other social media sites of the Animal Welfare League and the DeSoto County Animal Shelter will promote the T/N/R program so that neighborhood groups can reach out about community cat colonies.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

The Animal Welfare League (AWL) uses its transport van to assist clients who have no transportation options. Charlotte County provides translation services on an as-needed basis.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

The AWL's transport van is a standard cargo van equipped with straps to hold crates and carriers in place. Intake personnel is trained and insured to operate the van. All staff at the AWL go through animal behavior training. When transporting feral cats back to their habitat, staff use a small mammal den designed to reduce human handling.

Vaccines and microchipping are funded through separate grant awards to the Animal Welfare League.

Part of the Animal Welfare League's contract with Charlotte County pays for some of the costs of spaying/neutering low-income county residents. Also, some of the expenses associated with this project are funded through other grant awards supporting community collaborations.
