# Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the capacity to carry out this program.

Feline Friends of Southwest Florida specializes in TNR services for the public. Cats are humanely trapped and brought to participating spay/neuter clinics as well as to veterinarians in private practice. There are many component parts in order to have a successful TNR program. We have developed and put programs into place which maximizes our efforts and offers a safety-net for vulnerable cats and kittens by way of foster care and eventual adoption through local shelter partners. There are times when intervention is needed to get a cat off the street and into adoption. We have been able to successfully address those occasional issues. Also, no kittens are left behind in a colony that are young enough to be adopted into homes. It is our practice to intake the nursing female in additional to her kittens regardless of her temperment (feral or friendly). We allow feral females to nurse their kittens while we keep the kittens socialized to humans until they are of appropriate age to go into an adoption program. A nursing female in our possession who has weaned her kittens in our adoption program will be spayed and returned to her colony and caregiver. Another facet of care that we have implemented is treating sick or injured outdoor cats that need medical care in addition to spay or neuter. These cats are otherwise healthy, and a medical intervention is all they need to go back to being a healthy cat. For routine spay/neuter surgeries, cats are returned to field the following day after surgery to the same location in which they were trapped. Post TNVR education is key for long-term success. We encourage caregivers to stay in contact with us, offering suggestions and making recommendations on how to keep their cat colony healthy. We let them know we are available to help medically if cats need assistance later on. Cathy Worster, Caroline Resnick, and Nancy Colby are the founders of Feline Friends of SWFL. Cathy Worster has been involved in TNR for 9 years and cared for a colony of cats in New Jersey. Cathy is currently responsible for the daily management and interactions with volunteer trappers, coordinating surgery dates with spay/neuter clinics and veterinary offices. Caroline Resnick has been practicing TNVR for over 20 years. Prior to forming Feline Friends, she served on the board of the Animal Rescue Coalition and was the volunteer coordinator of their feral cat program which provided free TNVR services to over 1,500 outdoor cats annually. Caroline also served on Cat Depot's Advisory Board. Her area of specialty is coordination and logistics of mass trapping efforts. She is also in charge of grant writing and fundraising efforts. Nancy Colby has been involved in animal welfare for over 20 years and strongly supports TNVR efforts. She is active with Southeastern Guide Dogs, fostering puppies that ultimately become guide dogs. Nancy started a program with Feline Friends called 'I'm Special,' educating the public on the many rewards of adopting and caring for special needs cats. Nancy served on the advisory board of EARS Animal Sanctuary, and Cat Depot. Our trappers are seasoned and experienced professionals who volunteer their time and have been trained through our program on how to safely trap cats. Each trapper has approximately 10 or more years of TNVR experience. Cathy Worster and Caroline Resnick, co-founders of Feline Friends will be the responsible party who will carry out the grant's terms and conditions. Cathy and Caroline will also be responsible for providing all necessary paperwork at the completion of the grant cycle.

Feline Friends provides free TNVR services for the community. To qualify, there must be a caregiver to provide care for the cats and the cats must be able to be returned back to their location after surgery. When cats or kittens are adoptable, we make arrangements to get them into foster and eventual adoption. We collaborate with Sarasota County Animal Services when there are return to field projects.

# Objectives

#### What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

Our goal is to immediately stop continual breeding cycles and to reduce the suffering of kittens being born outdoors. Adoptable kittens will be removed from the location, automatically decreasing the number of cats in a colony. The decrease in numbers is measurable immediately upon removal of kittens. Once remaining cats are spayed and neutered, there is also an immediate and permanent halt to breeding which stops numbers from increasing. Those numbers can be measured immediately post surgery. Attrition will occur over time and numbers will decrease, and eventually the colony ceases to exist. Those numbers can be measured yearly.

#### How does this program increase the number of sterilization surgeries above the existing baseline?

The goal is to provide an additional 272 spay/neuter surgeries to reach more cats that would otherwise not be sterilized.

## Methods

#### What criteria will you use to determine eligibility for your program?

The boundaries for the proposed grant encompass south Sarasota County, Charlotte County, and DeSoto County. More specifically, incorporated and unincorporated towns, including but not limited to Englewood, Placida, Rotunda West, Port Charlotte, North Port, Punta Gorda, Burnt Store, Cleveland, Venice, Osprey, Nokomis extending east to Fort Ogden, Arcadia, and adjacent rural townships. The above-mentioned areas took a direct hit from Hurricane Ian in September of 2022 sustaining significant damage. The coastal communities of Englewood, Placida, Rotunda West, and Venice were in the eye wall of the hurricane having to endure sustained winds exceeding 125 mph for more than 8 hours resulting in catastrophic damage to housing structures and area businesses. The inland areas of North Port, Port Charlotte, and Arcadia sustained significant damage from flooding as the Peace River rose over 25 feet in the days following Hurricane Ian. Emergency evacuation orders that were put into place caused many familes to evacuate leaving pets behind. Many single-family homes and mobile home parks were destroyed displacing families who have not returned to the area. There are many unaltered cats in the area and there are no TNVR programs or affordable spay/neuter programs in DeSoto or Charlotte counties to stop the uncontrolled breeding. Any feral or free-roaming outdoor cat populations in the targeted area are eligible for this program.

#### How will you advertise the program? Explain how the advertising will reach the target audience.

Feline Friends of Southwest Florida will utilize several media venues to advertise the availability of our services and FAF grant funding. We will advertise on our website and post on social media. We will also advertise in local publications, including the Charlotte Sun which has an Arcadia edition and the Sarasota Herald-Tribune.

#### How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

We have the ability to use software from our iphone that can translate Spanish and English which enables use to handle any barriers we encounter. We also have Spanish fliers that explain the TNVR process.

# Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

We take safe transport very seriously, especially since we live in a tropical climate with heat indexes in excess of 100 degrees during the summer months. Vehicles used by our volunteers are SUVs with indoor climate-control. Pickup trucks are allowed ONLY if cats are transported inside the climate-controlled cabin. We do not under any circumstances allow cats to ride in the back of an open pickup truck.

# **Veterinary Services**

#### What arrangements have you made with veterinarians to perform the surgeries?

The Humane Society of Sarasota County will be the lead veterinarian for this project. They currently handle our feral cat surgeries. Humane Society of Sarasota County has the capability and capacity to increase their high-quality surgery volume for this grant and can do upwards of 120 surgeries a month. We also have veterinarians in private practice willing to assist with sick and injured cats and spay/neuter backup.

#### If necessary, please explain the procedures and fees described above:

The cost to spay or neuter a feral cat is \$55 per male and \$55 per female sterilization. Built into this cost includes staffing, disposable surgical supplies, pain medications, anesthesia, and dissolvable gut sutures. In addition to these services, the cats also receive Rabies and FVRCP vaccinations and ancillary medication to speed up the healing process which includes Revolt and praziquantal by injection to knock down the parasite burden. The costs for Rabies vaccines, FVRCP vaccines and additional ancillary products have been removed from the proposal and are not part of FAF grant. The cost of \$15.00 per cat will be paid for out of Feline Friends' general funds to cover these additional items.

# Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

There is no cost to performing basic examinations and no cost for ear tipping Both of these services are performed by veterinarians. Rabies vaccines, FVRCP vaccines, and parasite control are given to every cat. The total cost of \$15.00 per cat is not part of the grant and will be paid for out of Feline Friends' general funds. Optional microchipping and FeLV/FIV tests will be paid for by Feline Friends or caregiver. In the event an FeLv/FIV test or bloodwork is recommended by a veterinarian, Feline Friends will absorb the cost and will be paid for by Feline Friends' general funds.

# Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

A fundraising effort is planned this spring to raise spay/neuter funds for kittens. We have a donor who will match the total rasied by the public. This will be a collaborative event with the Venice Cat Coalition, a local TNVR nonprofit group. Money raised will go towards spay/neuter of outdoor kittens that are adoptable and originally part of an outdoor cat colony and won't be part of the FAF grant funding. Future funding of our TNR program will be accomplished with continued individual donations and fundraising efforts. We have a growing social media following and ask for their financial support especially during fundraising campaigns. We have also cultivated a year-end mailing fundraising drive which lists our accomplishments for the year. We anticipate growth in this fundraiser as our donor base continues to grow yearly. We currently have two generous benefactors who will match public donations dollar for dollar during these fundraising campaigns, generating excitement in donors and doubling the impact of our fundraising efforts. We manage a small but productive coin bank program which are placed at strategic high yield locations. We also have a monthly giving program.

We will inform the public of our success with FAF projects in particular and will encourage the public to purchase Florida Animal Friend license plates so projects like ours can continue to be funded.
