Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the capacity to carry out this program.

FHS has had a low cost spay/neuter program since 1992. Years ago we worked with local participating veterinarians. Today, nearly all of our surgeries are performed in house, with a small percentage going out to cooperating local veterinarians. Our medical team is well establiahed. Led by medical manager Joelene Osterhout, who trained as a phelbotomist but moved to animal welfare over a decade ago. Her team works well with a variety of veterinarians. We have a full time doctor, Dr. Carlos Aguiar who came to us from First Coast No More Homeless Pets, as well as several relief and part time veterinarians, Dr. Pam Kaitkowski, Dr. Cassie Triplett and more. They operate a wellness clinic as well as performing spay/neuter on shelter and owned animals.

Florida Animal Friend grants are for low-cost and/or no-cost spay/neuter programs; If you currently have such a program, please describe

We have been providing low cost sterilizations for decades. We do not require proof of low income or county residence. Our thought is that if our assistance is needed, then we will do everything we can to help. Our veterinarian performs a pre-surgical exam prior to all surgeries to ensure safety.

| Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area: Statistically, unaltered pets belonging to owners with financial hardships account for at least 85% of the unwanted pet population. We see so very many of these pet owners when they use our vaccine clinics, our low-cost wellness clinics and pet food pantry. If we were awarded the FAF grant we would offer fee waived sterilization surgery to lower income pet owners as needed. Compliance skyrockets when fees are waived, even low cost fees can sometimes be too much for people. Fee waived surgeries will provide a vital piece of the puzzle to reduce the number of surrendered and potentially euthanized pets in Flagler County and beyond. |
| What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs? Our low cost program which originated in 1992 is pretty much the only low cost option in Flagler County. FHS Low Cost Spay/Neuter program is staffed by our doctors and techs inside the shelter. Fees for surgeries range from \$110 to \$190 for male dogs depending on weight and from \$120 to \$200 for female dogs depending on weight. Cat surgeries are \$60 for a neuter and \$80 for a spay. We do surgeries three days per week, so we are able to keep up with the demand, we just cannot always help those who are unable to pay anything. Aside from us there is a very small group that has a low cost surgery program for cats. They have some internal issues, reputation issues and at best, they are limited to a quite small number of cats. Other than that, as a small incentive, a \$25 county spay/neuter rebate is available to Flagler County residents no matter which veterinary hospital they go to. They send in the receipt and we send them their \$25 rebate check. |

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

We are continually concerned that we could fail the most vulnerable animals - Animals who live in areas of severe economic hardships. As we analyze numbers within our shelter, we are tremendously successful. However, it is more difficult to gauge the population of animals that we don't see, the ones who don't make it to us. We know that hidden in our county, there are female dogs and cats giving birth whose offspring neither find good homes, nor end up in our shelter. We know there are male dogs who lose their homes because of negative behaviors which could have been solved by neutering them. Targeting our lower income areas with spay/neuter opportunities that are truly within their budget will not only save lives, but it will improve quality of life for pets and their owners. In many of these cases, we subsidize surgeries even beyond our low cost deal, however, our budget constraints are such that we are unable to help everyone without grant funding from an outside source such as Florida Animal Friend. If we follow the formula within this grant application, we have well over 56,500 cats and 68,500 dogs living with pet owners in our county who have fallen into poverty. We appreciate that over the years FAF has helped us provide owners with assistance to take the better care of their four legged family members.

How does this program increase the number of sterilization surgeries above the existing baseline?

In his third year with us, Dr. Carlos Aguiar who trained both at University of Florida and abroad, is a skilled surgeon with an unmatched record of safety. He performs surgeries quickly and even keeps the staff entertained. We have relief doctors, Cassie Triplett, Pam Kaitkowski and Tom Freiberg who handle our wellness and vaccine clinics so Dr. Aguair can focus everything on sterilization surgeries. Dr. Aguair formerly worked at First Coast No More Homeless Pets in Jacksonville. If we are ever unable to keep up with the demand in a timely manner, we have veterinary friends within the community that would help us temporarily. Our roadblock is often cost. Our customer service staff comes to me regularly saying that we have customers asking if we have grant funding available because although our spay/neuter prices are low, they are still more than what some can afford.

Methods

What criteria will you use to determine eligibility for your program?

A brief interview will be conducted either out in the field by our animal services officer, or in our lobby with a walk in or phone customer. We don't want to deny an animal in need. So although proof of residency and identification will be required and there will be an interview, we will not require proof that the pet owner is on government assistance. Too often people who work hard and are in need of assistance fall through the cracks when so much is required to determine eligibility.

How will you advertise the program? Explain how the advertising will reach the target audience.

Locals have heard of the Florida Animal Friend license plate grant funding, so it will spread quickly by simple word of mouth. In addition to that, flyers will be posted in social services buildings such as the County's Health Department. There are several family parks in our lower income areas at which our officers can post flyers. We have three Facebook accounts (the primary shelter FB, Animal Services and our Thrift Store). Information regarding the grant will regularly be posted on Facebook and our website, possibly even our business "Nextdoor" account. We can include flyers in bags at our thrift store and we even have a Pizza delivery place that has allowed us to post flyers on Pizza boxes. We will mention the grant funding on our radio show "Speaking of Animals" which airs in Flagler County Saturday mornings and on demand on line at WNZF. Much of the advertising for an opportunity like this is done by our officer speaking directly to pet owners in the community. Locals have heard of the Florida Animal Friend license plate grant funding, so it will spread quickly by simple word of mouth.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

We are blessed to have staff from various cultural backgrounds and who speak various languages. If there are language barriers or prejudices against a certain staff member, then we can match the messenger so that pet owners feel comfortable with whomever is speaking with them. Our forms are brief, and employees or volunteers often read them to pet owners who have literacy issues. Our officers often transport animals belonging to pet owners who do not have available transportation. If officers are busy, we have a volunteer network that signs up just to run errands involving animals. There would not be an issue with helping get animals to and from their surgery appointments.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

FHS has a total of five vehicles. We have one basic animal control truck, with metal cages built in the back of the truck. This truck is safe to transport large and small dogs, even unruly dogs. We have two vans which can transport multiple dogs inside as we stack wire crates inside in air conditioned comfort. We also have two other vehicles that are used simply for shelter errands. Either of those are fine to transport dogs, if the primary vehicles are in use. If someone other than our trained officers or staff is providing transport, we would send a pre-approved volunteer that has some training in animal handling. Liability waivers that have been approved by our board attorney are used. We would only be transporting the animals, not the dog owners.

Veterinary Services

What arrangements have you made with veterinarians to perform the surgeries?

Our facility has a large surgical suite with areas for prep and recovery. Our primary doctor, Dr. Carlos Aguair is a skilled surgeon with a passion for sterilizing animals. We also have Dr. Cassie Triplett, Dr. Pam Kaitkowski and Tom Freiberg who fill in as needed. If demand exceeds our ability to provide needed services in a timely manner, we have friendships with some local and nearly local hospitals who can help a bit with overflow.

We never turn any animal in need away.

Rabies vaccines and pain relief are included in the price. Other options such as an elizabethan collar, additional vaccines, diagnostics or parasite control will be the responsibility of the owner. For anyone who truly cannot afford anything that is needed for the animal, we will absorb the cost.

Our thriving thrift store, government contracts, fees for services and fundraisers all contribute to our ability to assist pet owners in need. We watch for specials from our vendors and deals on short dated products as well. We just had some microchips donated from Fi. Our members are willing to donate and happy to be a part of a winning, life-saving team. Also, as fewer animals enter the shelter thanks to spay/neuter, the resources that would have gone to housing pets, are better spent vaccinating and microchipping pets who will not be residing at our shelter.

Future Funding to Sustain Public Spay/Neuter

We are committed to continually offering low cost and free spay neuter programs. We celebrated forty years of service last year, with our low cost spay/neuter program nearly thirty years old itself. We are well established and respected within the community, so we aren't going anywhere (in a good way). Thanks in part to previous grants from Florida Animal Friend, our intake of animals drops nearly every year. With fewer animals residing in the shelter, there's less strain on a tight budget. If we can assist the owners who are in financial distress, then ourintake numbers should continue to drop. Less intake of animals means that funds that would normally be spent on care staff, food and supplies could then be used on programs to help animals outside of the shelter, including spay/neuter. We watch for grant opportunities help us to offer more assistance to pet owners. We partner with local pet stores, some of which have national grant programs. We are a part of the Million Cat Challenge, we send our stats in to Shelter Animals Count, we are partners with Best Fiends, ASPCA and HSUS. FHS Facebook has one of the largest list of followers in Flagler County. When we put out a plea on Facebook, the response is amazing. Our other social media outlets are expanding. We publish both hard copy newsletters and eblasts to help in our fundraising efforts.
