The Florida Keys SPCA is the only open-admission welfare organization serving the middle and lower keys from mile marker 0 through mile marker 70. Our organization is comprised of two campuses, located in Marathon, FL, and Key West, FL. Between our two campuses, we accept every animal regardless of health, species, and temperament. We are a proud participant of the Shelter Animals Count and our Live Release Rate for 2022 was 91%. Our Key West campus has a state-of-the-art surgical suite as of 2019 and our Marathon campus of late 2020 launched its first spay/neuter clinic in a donated surgical trailer. We currently have a full-time shelter veterinarian, clinic manager, veterinary assistant, and admin assistant dedicated to the clinic department. Our shelter veterinarian has worked in HVHQSN for the past 5 years with a strong background in high volume for large breed dogs after working in a facility with over 700 dogs on the property.

Florida Animal Friend grants are for low-cost and/or no-cost spay/neuter programs; If you currently have such a program, please describe

The FKSPCA is dedicated to spaying and neutering all our cats, dogs, and rabbits prior to adoption at both campuses. Additionally, we provide TNVR for community cats. Our shelter veterinarian, clinic manager, animal control officer, and operations director work alongside each other to also ensure that our low-income residents in our community also have access to these services at no cost. We currently offer three days a week dedicated solely to providing these services to the public and one day a week dedicated to TNVR for community cats. Funding is currently obtained through donations and fundraisers. With the high cost of living increasing by 2.9% in 2022, low-income residents have an increased disadvantage in our community's affordable spay and neutering services. There has been an increased demand for low-cost/free spay and neuter in our area as there are currently none in the middle and lower keys. This increased demand needs additional resources to meet the needs of our community.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

The main objective the FKSPCA hopes to achieve with these funds is to reduce the number of owners surrendering their pets due to financial restraints and/or behavior that could be circumvented by sterilization. To ensure organization and community goals are met, monthly intake reports will be the main metric of measurement.

How does this program increase the number of sterilization surgeries above the existing baseline? With the addition of a full-time high-volume shelter veterinarian to our clinic team, we now have the ability to offer these services more frequently as well as perform a larger

volume of surgeries per public surgery day. With the addition of our secondary locations' spay and neuter program expanding, we increase our physical accessibility for the residents in our target area.

Methods

What criteria will you use to determine eligibility for your program?

Proof of residency within our 70-mile jurisdiction is the only eligibility requirement for free services.

How will you advertise the program? Explain how the advertising will reach the target audience.

We aim to reach our target audience through our partnership with the SOS foundation (our local food bank) and the Florida Keys Outreach Coalition. As the contracted animal control agency for our target area, our animal control officer will be actively promoting our low/cost spay and neuter services while in the field and will be able to put individuals in direct contact with clinic personnel. We place local ads in local publications, a daily PSA runs on US1 Morning Magazine and a featured radio show in our target area. Additionally, the FKSPCA utilizes our social media accounts and email newsletters to help advertise our services. Our Facebook page has over 66,000 followers, our Instagram account at 2,518 followers, and our Tiktok has 15,700 followers.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Our diverse community members are met with every possible effort made by the FKSPCA to allow them to have access to care. All clinic documents and instructions are made available in both English and Spanish as well as having a fluent bilingual Admin assistant to ensure that all verbal communications are understood by both parties. Having multiple staff members being bilingual allows greater incite into handling cultural hurdles. Transportation assistance is available on a case-by-case basis, and having two campuses in Key West and Marathon makes our services easily accessible to our community.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

This project does not involve the transportation of animals by anyone other than the client. However, transportation assistance can be provided on a case-by-case basis if a lack of transportation is preventing the pet owner from sterilizing their animal. If this case arises, we can provide transportation by our Animal Control officers in our animal control van. Our officers are covered under the FKSPCA organization insurance and are trained in animal handling techniques. If transportation is provided by the organization, the pet owner will sign a release and liability waiver.

Veterinary Services

What arrangements have you made with veterinarians to perform the surgeries?

The FKSPCA has a full-time DVM on staff, who is an experienced high-volume spay/neuter shelter veterinarian. Dr. Katie Billmaier prioritizes consistent spay and neuter clinics four days a week between our two campuses.

What is the fee range to be paid for spay and neuter and what is the distribution to be paid by the client vs. the grant program? Our organization proudly offers multiple resources to help keep animals in the home through our safety net program, behavioral helpline, and our safe haven program but the FKPSCA believes that the main proponent in controlling overpopulation in our community is accessible spay/neuter programs. Our spay/neuter program is completely funded by donations, the Florida Animal Friend grant would enable the FKSPCA to designate the necessary funds for free spay/neuter for our low-income residents and community cat caretakers that would otherwise not be able to access them.

Future Funding to Sustain Public Spay/Neuter

As of late 2022, our Key West campus has become fully operational with the addition of a full-time staff veterinarian allowing us to host consistent revenue sustainers such as our biweekly Wellness clinics. With these now consistent wellness clinics alongside clinic fundraisers such as our Spay-ghetti & No Balls dinner and in-person counter donations, we are able to focus on making our Marathon campus fully operational which will provide additional revenue dollars that we did not have in previous years helping to sustain the program for the future.

Our organization will send a press release to the 3 main print publications in our target area upon receipt of the grant, along with showcasing an editorial piece on our own website alongside the already present Florida Animal Friend link on our home page. We currently display the Florida Animal Friend promotional materials in our lobby and will add marketing materials regarding the program to each of our adoption packets, spay and neuter clinic discharge packets, as well as display the materials during our weekly wellness clinics.
