GSAL was established in 2003 and since that time has provided TNR services to our community. We are regularly called upon by Manatee County Animal Welfare, Humane Society of Manatee County and community government to assist residents with issues relating to free-roaming cats. One of our specialties is the planning and execution of mass trappings of large free-roaming colonies where an entire colony is trapped at one time for TNR. Since the creation of a collaborative partnership made between MCAW, HSMC and GSAL in 2017 to provide a county-wide TNR program, we have seen a maintained save rate of 95% for cats entering the county shelter. This proves that TNR is a life-saving program. GSAL has successfully completed FAF grants awarded to us in 2010,2012,2015,2017,2019 and 2021. Our president and treasurer have implemented and managed these funded programs with positive completion. Our volunteers provide TNR assistance, education, information and guidance to community residents. Our volunteers are committed and compassionate for the well-being of our community cats and spend countless hours of their own time to support our mission. Many volunteers provide foster care for adoptable cats and kittens coming from our trapping locations until ready for adoption.

We give special attention to lower income mobile home parks, rental housing and transient neighborhoods as the concentration of unaltered animals in these area is high; and the available income to provide veterinary services in these areas is low.			
Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:  The financial inability for residents to have their pets spayed/neutered, allowing them to roam free and breed. Abandonment of animals due to foreclosures, senior pet owners who have passed or moved to facilities; and a significant number of transient neighborhoods are contributing factors leading to cat and dog overpopulation.			
What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?			
For pet owners who can afford to pay for services there is an adequate number of veterinary hospitals. However, for low-income owners and free-roaming cats, the Humane Society of Manatee County (HSMC) runs a high-volume reduced cost s/n clinic. GSAL provides resources to the community by assisting with trapping free roaming cats as well as transporting the cats to and from the HSMC clinic for surgery. GSAL provides this service free of charge as most residents we assist could not obtain these services otherwise.

# Objectives

### What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

To reduce the breeding population of free-roaming cats by 462 cats. This in turn immediately ends the breeding cycle of these outdoor cats and decreases the number of countless unwanted kittens that would otherwise flood our local shelters and rescues. Adoptable cats and kittens will also be immediately removed which further reduces colony size.

## How does this program increase the number of sterilization surgeries above the existing baseline?

Our baseline is determined by funding. In 2022, 384 free-roaming cats were sterilized through our TNR program. Additional funding would allow us to increase the current baseline by 462.

### Methods

### What criteria will you use to determine eligibility for your program?

Any free-roaming cats within our target area are eligible for the program as long as permission is obtained from the property owner and/or caretaker. Additionally, any free-roaming owned cat is eligible if the owner can demonstrate financial need.

## How will you advertise the program? Explain how the advertising will reach the target audience.

Advertising for this program and FAF grant funding will done by the means of using social media, news media, website, signage, flyers and word of mouth. We will also communicate with other shelters and rescue groups to advertise the availability of this program for residents seeking assistance with TNR.

### How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

GSAL will provide transportation to and from the surgery clinic for cats going through our TNR program for anyone without means to transport. We have several volunteers who are fluent in Spanish and Russian who can handle any language barriers we may encounter. We also distribute flyers in Spanish that outline the TNR process. We have never encountered any illiteracy or cultural hurdles that we haven't been able to overcome. However, if any arise we will take every step needed to overcome these issues and provide assistance where needed.

# Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Our primary source of transportation is a fully equipped vehicle specifically designed to transport animals. Volunteers can also provide transportation using trucks and vans, if needed. When using alternative vehicles for transportation, cats will be transported inside climate-controlled cabins. Our volunteers are trained in the safe handling of stray/feral cats. Cats will be kept in humane traps with trap covers during transport, holding and return, to avoid injury to the cats and others. Release forms are signed by the property owner, pet owner and/or caretaker giving GSAL permission to provide veterinary care and hold GSAL harmless.

Humane Society of Manatee County will perform the surgeries at their high volume spay/neuter veterinary clinic. Companion Veterinary & Urgent Care Center is also available to provide spay/neuter surgeries, if needed.

Gulf Shore Animal League will concentrate on targeting locations where sizeable colonies of free-roaming cats have been identified. We will perform large massing trappings at these locations so the entire colony of free-roaming cats can be trapped for TNR all at once. Mass trapping creates quicker results over a short period of time and will be more effective than trapping a few cats at a time over several weeks or months. Mass trappings also makes the most efficient use of our volunteer time and resources.
