For more than 80 years Halifax Humane Society (HHS) has existed as an open admission shelter to serve all residents and animals across Volusia county. HHS addresses the needs of 25,000 animals annually through our programs which all support our mission of caring for the lost, abandoned, abused, and neglected animals while striving to reduce pet overpopulation through strategic spay/neuter initiatives. HHS understands that adoptions alone will not end euthanasia and pet overpopulation and therefore opened the Redinger Clinic a Humane Alliance low cost spay/neuter clinic in 2012. Since that time over 65,000 animals have been sterilized through that facility alone.

Florida Animal Friend grants are for low-cost and/or no-cost spay/neuter programs; If you currently have such a program, please describe

Private practice veterinarians in Volusia county charge current market rates (ranging from \$200-700) and serve middle to high income families. Currently there are low-cost spay/neuter services available through Halifax Humane Society's (HHS) Redinger Clinic and Volusia County Animal Services. Limited Services offered by the County are distance prohibitive for many residents and have limited capacity. Available resources typically help low-income residents but are completely inadequate for those living in poverty. HHS' Redinger Clinic offers cat spay neuter surgeries at \$45 each and dog spay neuter surgeries begin at \$60 and go up to \$135 depending on size.

Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

To leverage grant funds to achieve desired outcomes, HHS will: 1. Sterilize at least 500 animals between October 2, 2023 and August 2, 2024 depending on the mix of intact male/female cats/pit bulls presented. 2. Offer subsidized spay neuter surgeries for cats and pit bulls to further reduce annual intake and prevent overpopulation. The cost of anesthesia, surgery, and pain meds will be covered 100% through grant funding. A modest co-pay reduces the no show rate allowing us to maximize our surgical capacity while

helping to defray the cost of rabies vaccinations, microchips, and any potential surgical complications. 3. Bring awareness to the community about Florida Animal Friends funding and how participation can help ensure future funding to benefit our community's animals through social media, e-blasts, and monthly magazine.

How does this program increase the number of sterilization surgeries above the existing baseline?

Currently, HHS' Redinger clinic consistently fills 29 surgery appointments per day at our standard low-cost rates but has the capability to perform up to 35-50 surgeries per day. This grant funding will provide the necessary resources to those who lack the most basic financial means and should increase completed surgeries by at least 10%.

Methods

What criteria will you use to determine eligibility for your program?

1. Individuals suffering financial hardship will be given priority to participate in this subsidized program. This is encouraged through strategic marketing efforts to low-income and targeted areas. 2. Since cats are prolific breeders and pit bulls represent nearly half of all dogs entering HHS in 2022 with increasing breed specific housing restrictions – these populations will be aggressively targeted to participate.

How will you advertise the program? Explain how the advertising will reach the target audience.

Program specifics will be shared with all HHS community partners to ensure that the targeted populations are reached and served. Any remaining availability will be promoted to those that qualify through daily requests for free spay/neuter services, those owners who present at the shelter contemplating surrender due to lack of resources, social media, PSA's with media partners, e-blasts, news release and other multi-media blast sources. We have created a partnership with Southern Stone Communications which runs 6 radio stations(95.7, 103.3, 93.1, 99.5, 94.1, 93.5). They have committed to running a 30-second commercial spots for HHS programs and events monthly on targeted audience stations.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

HHS' Redinger Clinic is centrally located in Daytona Beach making it convenient for pet owners. Promotional flyers will provide details about the program and the positive benefits of spay/neuter in both English/Spanish and will be distributed through our outreach partners and posted in strategic locations in high poverty communities. Staff will be trained to properly explain the program to qualified pet owners who may not understand printed literature to ensure their participation

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Animals are typically transported by pet owners. If, however, it is determined that transportation is a substantial barrier to participation, HHS would work to provide a solution to ensure the expected outcome. This will be determined of a case by case bases.

HHS' Redinger clinic is a humane alliance model community spay/neuter clinic in Daytona Beach, Florida. Our In-House Veterinarians and their highly skilled team of HHS employees will perform all procedures.

To ensure compliance with state and local rabies law, rabies vaccination will be required without proof of current vaccination status. Elective vaccinations and pet care products are offered at discounted rates. HHS as part of our mission requires all animals to be micro-chipped to ensure that lost animals are promptly returned to owners.

HHS understands that adoptions alone will not end euthanasia and pet overpopulation and therefore opened the Redinger Clinic a Humane Alliance low cost spay/neuter clinic in 2012. Since that time over 65,000 animals have been sterilized through that facility alone. Community cats and bully breeds are the most significant part of our community's continuing pet overpopulation. That combined with entrenched barriers such as poverty and cultural resistance make this grant funding critical to our ability to reduce unwanted litters and unnecessary euthanasia.

Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

The \$10 co-pay for cats and \$25 co-pay for dogs, will help defray the cost of rabies vaccine, microchip, or unforeseen surgical complications when necessary. Grant funds will cover the cost of anesthesia, surgery, and pain medication. Any requested elective services will be paid by the pet owner.

Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

All municipalities are strongly encouraged to participate in Return To Field programs which will address the prevention of cat over population and thereby reduce both the municipality and HHS' resources directed to housing and possible euthanasia. Profits from Redinger clinic will subsidize costs not covered by this grant to ensure that our targeted audience is adequately served. The community provides donations to support this important initiative which will help cover the rising cost of vaccines, inflation, medical supplies, and the additional cost of more invasive spay procedures in large dogs.
