Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the capacity to carry out this program.

We have built a very strong partnership with our animal control and realize the need to have a voucher program offered to help reduce the amount of large breed dogs coming into animal control. A total of 619 dogs were saved from Polk County Animal Control in 2022. Out of 38 Rescue Organizations total that pulled dogs, Only 6 organizations pulled more than 10. We were the only organization to pull over 100. We pulled almost 1/2 the dogs saved last year, over 208 more dogs than any other organization. We pulled 273 dogs. How does this relate to a spay and neuter voucher program? We built our programs to save this number of dogs from the ground up and have the connections with our animal control to have the largest impact possible getting the word out. We greatly need to reduce the number of large Bully breed dogs going into animal control to reduce the euthanasia rates in turn.

There are 43 veterinary clinics in Polk County and only one of those is an HQHV practice. PCBP is happy to work with veterinarians in the county and veterinary services are currently at a higher cost than the community us able to afford.

# Objectives

#### What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

We call this voucher program PAL for Pitties, (Prevent A Litter). We hope to start a voucher program to reduce the over population that is happening in our county with pit bulls and bully breeds. We will offer these vouchers to low income applicants. Bully Breeds have large litters historically and are the ones least likely to be adopted when they make their way to the county shelter. Those dogs designated pit bulls are not adopted out in Polk County. A primary goal is to provide public assistance for these owners that want to sterilize their dogs but are financially unable to do so. The additional goal of this funding is to decrease the number of at-risk dogs from entering the shelter.

#### How does this program increase the number of sterilization surgeries above the existing baseline?

There currently is no voucher program for the county of Polk. We have neutered and spayed over 500 dogs with TLC Petsnip over the past few years. We hope to offer this voucher program to the community to increase the spay and neuter of large breed dogs.

#### Methods

#### What criteria will you use to determine eligibility for your program?

The income-based criteria will be based on if the owner of the dog is on any type of government assistance.

### How will you advertise the program? Explain how the advertising will reach the target audience.

Polk County Bully Project will advertise this program on the website, flyers (English and Spanish), social media, press releases, and free-standing advertisements at the shelter. The target audience will be reached through these avenues as well as through events and word of mouth.

### How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Barriers that may need to be addressed are transportation, illiteracy, and culture will be done through volunteers. For example, PCBP owns a transportation van that can be utilized in certain situations to help make it to an appointment. The issues of illiteracy and cultural barriers will be addressed individually based on the client's needs. We can read and verbally explain the program to an applicant. An example of a cultural hurdle seen regularly in Polk County is the language barrier. Many low-income families are Spanish-speaking. For this issue, PCBP will solicit the assistance of Spanish-speaking staff and volunteers to help break that language barrier.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

The rescue will assist with transportation needs but encourage the client to seek other transportation assistance. For example, Polk County Bully project has a van that has been

fitted with cages that can hold multiple large dogs safely and securely. Should a client need transportation assistance, a liability form will be filled out and signed, showing that the rescue is not liable for any transportation-related issues. The clients will also be required to complete a surgical consent form for the facility to complete the procedure.

# **Veterinary Services**

#### What arrangements have you made with veterinarians to perform the surgeries?

Polk County Bully project works with several local veterinarians and will be utilizing them but primarily using TLC PetSnip for sterilization. Polk County Bully Project has a long standing relationship with TLC PetSnip and currently uses them for sterilization procedures. We have completed over 500 surgeries with TLC Pet Snip. They have a new surgery center with expanded availability so most appointments can be made within 30 days. We also have standing spots on every Monday. TLC PetSnip has agreed to assist with sterilization of pit-bulls and pit-bull mixes under this program.

We will be creating a separate website for registration and inquiry questions. Vouchers are provided to qualifying residents who request them on a first come, first served basis each month. Those who do not satisfy their voucher within the required timeframe will lose the service and have to reapply should they still be in need.

#### For your voucher program, how have you determined the capacity of the veterinarians listed above to handle the projected capacity?

We have had several discussions with the Executive Director and Medical Manager. They just opened an expanded surgery center in August of 2022 and can handle the additional surgeries. They have preformed over 500 surgeries for us in the past.

#### Will you have the ability to report the number of vouchers issued and the number redeemed for spay/neuter surgeries?

Documentation fromTLC Petsnip will include redeemed vouchers and invoices for each completed surgery. We keeps a roster of all vouchers issued and match documentation from the clinic against the total number of S/N surgeries performed under the grant.

We will set up an independent website link to apply for the grant. We have a medical coordinator that works closely with TLC PetSnip. We have access to the back end portal to schedule all our own surgeries and request service so that aspect of adding in appointments for vouchers will be seamless. We already have a structured system in place. We also have an account set up for automatic payment of invoices. Surgeries under this program can have automatic invoices generated to show compliance for this grant. We previously set up a free spay and neuter day with this organization backed by the Stand Up for Pits Foundation for Grant payment so we have a good idea on how to run this and the advertising portion of filling the vouchers.

# Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):

We have microchipping at a cost of \$6 per chip with FI Nano chips, rabies vaccine is \$15 and we will paying the licensing fee out of donations towards this program. On a case-by-case basis, we may cover the co-pay and/or rabies vaccination costs so the cost to the voucher holder is zero.

# Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

We have met with all of our county commissioners about the need for a voucher program in the county and presented at commission meetings. They are all in agreement and we feel like by getting this grant award we can double the impact and ask for an additional \$50,000 from the county and to cover a program for cats as well, last year they had agreed on a need to be at \$125,000 but as it all came out of the sheriff budget it was tabled to the next year. We feel extremely confident to get a match from the county of \$25,000 at the least. We will move forward with this program regardless. We will be actively applying for other grants that are offered for spay and neuter of dogs and cats and TNR programs to expand the reach. We will increase our on-line fundraising efforts as wel.

We hope to move forward with this grant award to keep it going for the next years with fundraising specifically for this program as well as demonstrating the need in this county and to have the county step forward to expand and fund this program and add in cats. The other counties that touch us have voucher programs and the truth is in the statistics of the amount of animals that end up being euthanized in the local shelter. We will be actively applying for other grants that are offered for spay and neuter of dogs and cats or county currently does not recognize TNR.. We will increase our on-line fundraising efforts.

We will be doing several promotional campaigns on social media and at our events. We do events every week with multiple events in any given week. We have 25k followers and a very active base. Animal control has also agreed to share this program as well and TLC Petsnip has also agreed to share and push this program. The success of this program is so critical to our agenda of change in this county.
