Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the capacity to carry out this program.

Regarding number of dogs sterilized, 12 dogs were returned to owner intact. Sadly, very few animals taken into the shelter are reclaimed by owners. The Hamilton County government will manage the Grant for the 3-county service area: Hamilton County and neighboring Suwannee and Madison counties. Animal Control Officer Rosalie Bonney is directly responsible for the NO MORE LITTERS Spay Neuter Voucher Program with her supervisor County Coordinator Gary Godwin providing oversight. ACO Bonney is a trained and experienced Animal Control Officer recently hired from a Georgia city animal control. Both have made major improvements to the facility and the County is in the process of building a new animal shelter. Recently an organization "Friends of the Hamco Animal Shelter" was established with a high priority being support for the Spay/Neuter program as well as other services.

Florida Animal Friend grants are for low-cost and/or no-cost spay/neuter programs; If you currently have such a program, please describe

The only program to assist the public is a cadre of donors who will pay one-half the cost of spay/neuter of pets belonging to low-income pet owners which was implemented this year. With this grant and the support of "Friends of the Hamco Animal Shelter" we can greatly expand subsidizing low-income pet owners and feral/community cat caretakers.

Please explain if you believe your target area animal population is significantly different than above.

The estimated population of cats and dogs in the target area is higher than the national average because this is a very poor rural region in North Central Florida. The identified counties average low per capita income of \$20,127, a high poverty rate of 22.7%, and a school drop out rate of 20.3%. The number and size of animal shelters and rescues in the area are underfunded and inadequate to meet the needs of the human and animal populations.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:

Big dogs, especially pit bull types, are very popular among the poorer citizens and they make up a high percentage of the dog population. There is a very large number of feral and community cats as well as owned cats. The vast majority of these intact animals are outdoors and often free roaming.

What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?

Hamilton County has no veterinary or spay/neuter clinics available. Suwannee County has two veterinary clinics that offer low-cost spay/neuter services: 'North Florida Animal Rescue and Vet Clinic' in Wellborn and a small low-cost clinic 'Suwannee PAWS' in Live Oak. Our participating spay/neuter clinic, the 'South Georgia Low-Cost Spay/Neuter Clinic' in Thomasville, GA (20 miles north of the Florida/Georgia border) also serves Florida counties.

Florida Animal Friend is highly supportive of proposals that are focused on animal populations that are identified as substantial sources of dog or cat overpopulation rather than being diluted over too broad of a geographic area or diverse animal populations. Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

We expect to increase our subsidized spay/neuter surgeries by a minimum of 400 big dogs (especially pit bull types), owned cats, and feral/community cats with caretakers. Owners and TNR/community cat caretakers pay the \$10 fee for rabies vaccination only. Pain medication is included at no additional cost and there is no charge for surgical complications such as pregnancy, in heat, pyometra, etc.

How does this program increase the number of sterilization surgeries above the existing baseline?

Hamilton County Animal Control Services assures all adoptable cats and dogs, whether adopted or transferred to other rescues, are spayed and neutered. In addition, we have sponsors who pay one-half of spay/neuter surgery for low-income pet owners. The NO MORE LITTERS spay/neuter assistance program will vastly increase the number of owned pets and feral/community cats being sterilized, not only with grant funds but through additional fund-raising by the "Friends of Hamco Animal Shelter."

Methods

What criteria will you use to determine eligibility for your program?

Pet owners must be receiving government assistance not exceeding 150% of the Federal poverty rate from SNAP Food Stamps, Medicaid, or SSI (Supplemental Security Income). Feral Cat Caretakers must commit to continued care for the cats and continue to spay/neuter all current and new cats in the colony. Community cat caretakers must commit to continuing care. Both must agree to periodic inspections.

How will you advertise the program? Explain how the advertising will reach the target audience.

We will distribute flyers in English and Spanish at places frequented by low-income families including health departments, libraries, Head Start, churches, etc. Press Releases to Newspapers and PSAs to radio and TV stations serving the target counties. Periodic posts in applicable social media groups, especially Facebook, which is very popular in this area. We use these sources for special events which is very successful.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Our volunteers and the newly formed "Friends of the Hamco Animal Shelter" will help as needed to overcome barriers including transporting pets for recipients who are unable to drive, translating for Spanish-speaking residents, etc.

Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Volunteer transporters will use their personal vehicles and be required to have experience handling animals, auto insurance, current driver's license, and sign a liability release form. The Animal Control staff may transport in their vehicle. All animals must be secured in kennels or traps. Volunteers who are not experienced in handling animals will be paired with an experienced driver while they learn required techniques.

Ear Tip mandatory for feral and community cats at no charge. There is no additional charge for physical examination, pain medication, or complications in surgery. Preventive vaccinations and procedures available at extra charge to the owners/caretakers.

Is this a voucher program? Yes

If so, how will you assure utilization of the program?

Applications are submitted to Hamco Animal Control and Services with proof of eligibility for approval. If approved, the Voucher number with details are entered in a database. The applicant is given their Voucher and Instruction Letter to make their appointment(s). Recipient submits approved voucher to the clinic at the time of appointment. The Clinic sends monthly invoices with submitted vouchers for payment. This serves as verification vouchers have been used. We continually have inquiries from pet owners and caretakers needing financial help to sterilize the animals. We are confident the program will be fully utilized.

For your voucher program, how have you determined the capacity of the veterinarians listed above to handle the projected capacity?

The Clinic is a well established, highly successful, full-time, high volume spay/neuter clinic and has proven fully capable of handling all the surgeries approved under this grant.

Will you have the ability to report the number of vouchers issued and the number redeemed for spay/neuter surgeries?

A log will be maintained to document Vouchers issued and when they are redeemed. When funds are expended, we will have necessary data to complete the final report.

The subsidized spay/neuter program targets low-income pet owners and caretakers who are unable to get their animals sterilized even at the non-profit clinics' lower prices. 'North Florida PAWS, Inc.' and the 'Friends of the Hamco Animal Shelter' are committed to raise additional funds and make this program a success on an on-going basis.

A rabies vaccination at \$10 is mandatory to be paid by owners/caretakers. All other vaccinations and services are at owners' expense. There are no additional charges by the Clinic for unexpected expenses due to medical complications, physical exams, pain medication, or ear tipping. All administrative costs such as advertising, printing, postage, gas, etc. are covered by the County.

Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.

Hamilton County Animal Control Staff, 'Friends of the Hamco Animal Shelter' and 'North Florida PAWS, Inc.' will conduct on-going fund-raising activities to sustain the NO MORE LITTERS spay/neuter assistance program.
