1. Owner surrendered animals – Citizens call SNIP to pick up puppies/kittens and their mothers. SNIP spays/neuters the animals and places them either in the care of nine foster families, partner shelters or to adopters. SNIP returns the mother to the original owner upon request after she is spayed. 2. Foster program – Currently nine families foster approximately 150 animals annually. 3. Disaster services - SNIP rescues stray animals after hurricanes/storms and is required by law to take the strays to Collier County Domestic Animal Services (DAS) and supplies dog/cat food to owners who need assistance. 4. Wellness services to underserved pet owners – SNIP provides low/no cost vaccinations, wellness exams and sterilization services to underserved families. 5. Cruelty investigations/Enforcement of Ordinances - SNIP vigorously works with local law enforcement, elected officials and DAS to alert them to unsafe conditions and or sick and injured animals they observe while out in the community. SNIP also advocates for more robust investigations and enforcement. 6. Volunteer program – community volunteers assist with all SNIP programs including fundraising, events, field work, advocacy, assistance in the clinic, fostering and helping with adoptions. 7. High volume spay and neuter clinic – SNIP operates a high volume spay/neuter clinic facility on Davis Boulevard in Naples that sterilized 2.895 dogs and cats in 2023. An additional 686 were sterilized through the TNR program in 2023. SNIP began offering TNR services in a mobile spay/neuter clinic in Immokalee. Over 60 feral and domestic cats were sterilized in the first two days of operation. SNIP's TNR operations alone sterilized 686 cats in 2023. 8. Staffing – Tom Kepp is the founder of SNIP Collier (founded in 2015) and is literally boots on the ground to rescue and transport injured or sick cats and dogs so they can be treated and sterilized. Jose Lopez is the clinic manager and a licensed veterinary technician (LVT) and a certified veterinary technician (CVT.)

Research conducted in Tennessee indicated pet ownership statistics in rural areas are significantly higher than the national averages. They found through estimates and informal surveys that the rural pet population is more likely 90% of the human population. In rural areas, more households have pets and keep more pets than average. Sadly, most of these pets are free-roaming and only about 30% were fixed before spay/neuter assistance was available. (Retrieved online 03/27/24: https://www.unitedspayalliance.org/rural-reality-more-pets-and-fewer-resources-means-some-communities-need-more-help/) 90% of Immokalee's population translates into 25,200 stray animals.

Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:

Lack of Spaying and Neutering: Failure to spay (for females) and neuter (for males) pets is a significant contributor to overpopulation. Uncontrolled breeding leads to more litters being born, adding to the population of unwanted animals. Irresponsible Ownership: Some pet owners do not take responsible ownership seriously, allowing their pets to roam freely without supervision or neglecting their care, which can lead to unplanned pregnancies and abandoned animals. Backyard Breeding and Puppy Mills: Unregulated breeding practices, such as backyard breeding and puppy mills, often prioritize profit over the welfare of animals. This can result in large numbers of puppies and kittens being produced without proper care or consideration for their future homes. Lack of Access to Veterinary Care: In some areas, limited access to affordable veterinary services makes it difficult for pet owners to spay, neuter, and provide proper medical care for their animals, contributing to overpopulation. Failure to Microchip and License Pets: Without proper identification, lost pets may never be reunited with their owners, leading to strays adding to the overpopulation issue. Abandonment and Stray Animals: Pets that are abandoned or lost contribute to the population of stray animals, especially if they are not spayed or neutered, allowing them to reproduce in the wild. Cultural Attitudes Toward Pets: Cultural attitudes toward pets and their care can influence overpopulation. In some regions, pets may not be valued as family members, leading to higher rates of abandonment and neglect. Addressing dog and cat overpopulation requires a multifaceted approach that includes promoting responsible pet ownership, education programs, increasing access to affordable spaying and neutering services, regulating breeding practices, and implementing measures to control the population of stray animals.

What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?

Outside of SNIP Collier's mobile clinic, residents do not have access to no/low cost spay/neuter services in the Immokalee community.

Florida Animal Friend is highly supportive of proposals that are focused on animal populations that are identified as substantial sources of dog or cat overpopulation rather than being diluted over too broad of a geographic area or diverse animal populations. Objectives

What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

SNIP Collier will utilize the \$25,000 grant to neuter/spay an additional 555 dogs and cats in the 12 months following the grant, of which at least 90% will be from the Immokalee area.

How does this program increase the number of sterilization surgeries above the existing baseline? 555 incremental animals sterilized represent a 15% increase in sterilizations over Fiscal Year 2023.

Methods

What criteria will you use to determine eligibility for your program?

SNIP does not require proof of income to provide services. Services are offered to those in need. SNIP also works with clients to accept monthly payments as low as \$5. Nobody is

turned away because of their inability to pay.

How will you advertise the program? Explain how the advertising will reach the target audience.

The program will be promoted utilizing social media and media releases. Founder Tom Kepp has a close relationship with local media and is constantly used as a "go-to" resource for source dog/cat issues by the media. Grassroots marketing has always been a trademark of SNIP Collier. Kepp and his team of volunteers go into communities throughout the county in the early mornings and Kepp goes to Immokalee two or three days a week. They knock on doors and pass out flyers with SNIP's information. People can sign up to have their dogs fixed for free and returned, or they can surrender their pets if they can't take care of them. SNIP then works with several local shelters to get the surrendered dogs adopted or places them in foster homes until they are adopted. SNIP Collier also distributes flyers at its community events, like "Rock the Block" held every third Thursday at the Mercato plaza from 6-9 PM.

How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

1. The Mobile clinic will be stationed primarily in Immokalee and staffed with at least one bilingual volunteer or staff person. 2. SNIP Collier has acquired the former Immokalee Domestic Animal Services land and buildings with a 30-year lease from Collier County (\$1 a year for 30 years.) SNIP is raising funds to update, renovate and construct additional buildings to help address the pet overpopulation crisis in Immokalee. The SNIP Immokalee Campus will feature a clinic and surgery center featuring spay/neuter services, kennels and holding areas for strays and an education center with an open-air pavilion. Bilingual staff and/or volunteers will assist in communication to clients.

Veterinary Services

What arrangements have you made with veterinarians to perform the surgeries?

SNIP utilizes in-house veterinary staff to perform spays and neuters. By law, SNIP Collier must deliver strays to Collier County Domestic Animal Services (DAS) who then spay or neuter them before they are returned to their owners and/or put up for adoption.

Feral cat package available to trappers for \$55 which includes spay/neuter, rabies vaccine, FVRCP, ivermectin, pain medicine, ear tip (required.) 2. A dog vaccine package – Exam, 1 yr./3yr. Rabies, DHPPL, Bordetella, Heartworm Test for \$100/\$110 3. Cat vaccine package - Exam, 1 yr./3yr. Rabies, FVRCP, FELV for \$80-90. 4. \$60 Puppy 12 week package – Exam, DHPPL, Bordatella, Dewormer 5. \$60 Puppy 16 week package – Exam, DHPPL, 1 yr. rabies 6. \$60 Kitten 8 week package – Exam, FVRCP, Deworm 7. \$60 Kitten 16 week package – Exam, FVRCP, I yr. In addition to the mobile clinic that is primarily based in Immokalee, SNIP Collier has acquired the former Immokalee Domestic Animal Services land and buildings with a 30-year lease from Collier County (\$1 a year for 30 years.) These buildings will be updated, renovated and addition buildings constructed to help address the pet overpopulation crisis in Immokalee. This low-cost veterinary clinic in Immokalee will be easily accessible for the most impoverished pet owners and for the SNIP team of volunteers who are in the field daily rescuing hurt, sick and vulnerable cats and dogs. The clinic will house a surgery center, an education center, recovery area, separate cat/dog rescue holding kennels, reception area and offices. SNIP clinics will also provide discounted spay and neuter services to local shelters to expedite the adoption process. By having a SNIP Collier Low-Cost Clinic in Immokalee, the number of unwanted pregnancies in both dogs and cats will be reduced.
