# Give additional background information on your organization's programs as they relate to this application and the qualifications of the personnel who will be in charge of this program. Show that you have the capacity to carry out this program.

The Cat Network is a 501(c)3 Florida not-for-profit corporation dedicated to humanely reducing cat overpopulation by educating the public about the need to sterilize their pets and strays; providing access to low or no-cost spay/neuter services; helping members in their efforts to place adoptable kittens and cats in loving homes; and advocating non-lethal population control and humane public policy. We are a membership organization with 1500 active members. Members include trappers, fosters, adoption center volunteers and TNR advocates. We run on the strength of our large volunteer network. We employ only three staff members which includes a long-term program manager and two veterinary technicians. Our contract veterinarian has been with us for 13 years and is highly respected in the TNR community. We hold monthly meetings with our members and our directors work tirelessly in the community to further advocate for the importance of TNR.

Our Meow Mobile which proudly sports a Florida Animal Friends license plate provides low cost spay and neuter surgeries, vaccinations and basic wellness care to cats and kittens in Miami-Dade County. #### Please explain if you believe your target area animal population is significantly different than above.

We believe the population is significantly larger for free roaming community cats as our members have identified this as a dumping ground for abandoned pets. Homestead City is considered less metropolitan, providing those who abandon a sense of comfort that they are abandoning not on a city street. Sadly instead they suffer terribly. The City's community enforcement agencies is becoming more vigilant however our members have pulled a significant amount of kittens from this area.

#### Please explain what you believe are the most substantial sources of dog and cat overpopulation in the target area:

The Wall Street Journal has identified that approximately 25% of pet owners are concerned with the high costs of pet ownership and that 50% of that population are considering abandoning their pet. This is the reality in South Florida. With the highest rate of inflation in the country and the cost of housing almost doubling, lower income residents are struggling to house themselves and often find that they can no longer keep their pet. Sadly with shelters full, these pets end up abandoned. Our members have rescued cats abandoned outside of full rescue facilities, in shopping carts or restrooms at pet stores or at the side of busy roads. This level of abandonment is not something the Cat Network has seen in our long existence. We are at a level of crisis and our volunteers are mobilizing to identify hot spots that need attention.

# What kinds of spay/neuter services are currently available in the target area and in what ways are these resources currently insufficient to meet community needs?

Homestead City offers low costs clinics with proof of residency. However with a high immigrant population fearful of government and the inability to afford even a low cost solution a better option is needed. The Cat Network runs with volunteer members active in the community. We are often approached in the local Petsmart or Pet Supermarket to help. Add to that, our President is from the Homestead area and is very familiar with specific locations such as Avocado School and the site of the old Mutineer restaurant where numerous cats have been trapped, sterilized and released but more resources are needed.

Florida Animal Friend is highly supportive of proposals that are focused on animal populations that are identified as substantial sources of dog or cat overpopulation rather than being diluted over too broad of a geographic area or diverse animal populations. # Objectives

#### What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?

We are in the fortunate situation to have the majority of our users of the Meow Mobile come to us. We have been established for many years in the South Florida community and we have a large network of members who use our low cost services for community cats or fosters as a benefit of their membership and are supported by Miami-Dade County for a portion of this program. These same members are letting us know of growing hot spots for abandonment and resulting exploding litters of kittens and community cat feeders in these areas. We have taken a large amount of kittens and from the Avocado School property as well as the site of the old Mutineer restaurant. We would like to target these areas and additional Homestead parks with trappers to bring cats to us. Our plan is to sterilize an additional 250 cats in this hotspot that would otherwise not come to us. Left alone this area will become an area of population explosion and we want to get ahead of this problem with a proactive solution. By sterilizing 250 cats in this know problem area we believe we can begin to turn the tide. We do not however have the additional funds at this time do do this as we can fulfill our current TNR goal with just cats that are brought to us. We have commitment from our member community to fundraise for the additional project in a time where many others are overwhelmed. We believe that we have the experience to find support with our 1500 members of which more than 300 are located in or close proximity to Homestead. We have an established network of trappers and we have our own Meow Mobile to perform the surgeries.

#### How does this program increase the number of sterilization surgeries above the existing baseline?

We currently rely on members to bring cats to our facility. Our proposed program would be to engage 5-6 trappers in the Homestead City area to target known"hot spot" areas for

expanding populations of community cats. Our goal is to sterilize 250 cats in this area that would otherwise not have used both our Meow Mobile or the city programs. By doing this we believe we can, in combination with increased community enforcement reduce the significant amount of litters that are being identified in the Homestead area. Our fosters are overwhelmed and we cannot adopt at the level of the outreach we are receiving. Our goal is to be proactive and by sterilizing 250 cats we believe we can significantly help the issue as well as bring community trust and awareness of the Meow Mobile as an option going forward. The cats we would target would be above the number we are currently funded by Miami-Dade County and above our current level that we supplement with membership fees and fundraising. In a year when the need is overwhelming our mission is to do more.

# Methods

#### What criteria will you use to determine eligibility for your program?

We plan to focus on identified hot spot areas in Homestead City for free-roaming community cats. These areas have been already identified by our members who have observed expanding populations and an increase in abandonments.

#### How will you advertise the program? Explain how the advertising will reach the target audience.

We have a network of 1500 members who work tirelessly to help the cat population in South Florida. We hold monthly meetings where problem areas are raised. Homestead City is consistently a source of cats into our foster programs. We will highlight this program in our meetings as well as reach out to our members specifically that live in this area. We have the advantage of many dedicated eyes as part of the Cat Network. We have over 300 active members living in Homestead or in close proximity and we believe that this advertising by local active community members is stronger than any other form of advertising.

#### How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?

Due to our longevity in the South Florida area as well as our network model we have a strong network of experienced trappers. We will use these trappers, many who are bilingual, to promote the program as well as carry out the transport.

# Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.

Our trappers are long-term trappers in the South Florida community. They are highly trained, compassionate individuals who are well connected in the community. They use humane traps of which the Cat Network provides and are compassionate in their understanding of the healing process. We have high expectations of those in our program and we only use people that we have established trust over the years. This network sets us apart in what we can accomplish.

## **Veterinary Services**

#### What arrangements have you made with veterinarians to perform the surgeries?

Dr Brian Huntsman has been working with the Cat Network for the past 13 years, 11 years as the primary veterinarian for the Meow Mobile. We have two additional vet techs and the labor cost considering these individuals is \$49 per cat. Our surgical team is well respected in the community and we are proud of our quality, efficiency and compassion for our patients.

All cats or kittens coming into the Meow Mobile are given an exam, rabies vaccine, parasite treatment and necessary pain medication. Costs incurred that are outside of the grant will be paid by the Cat Network. We have a standard of care for all Meow Mobile cats and we are willing to fund that above the level of the grant.

We are a member network with a tireless army of volunteers. Our volunteers have requested that we go to areas that they highlight as hot spots in the community. We would like to be responsive to these requests but do not have in our budget to immediately respond. South Florida is currently overwhelmed with the level of pet abandonments. However we are not an organization to turn away just because something is hard. Establishment of a program such as this which would focus on hot spots would allow our organization to be more responsive to our members. We want to be proactive and not reactive and we believe we have a strong opportunity here to be just that. We have the ability to track by zip code as well as a large member network who will be vocal as to whether or not we are making a difference.

We hope to use this project to build a repeatable process to discuss with cities and local school or community groups to create a more grassroots solution to a problem that is recognized by the community. If we can demonstrate that such a program is successful in Homestead we believe that we can obtain additional grants from cities or fundraise in specific zipcodes to address identified problems. We would like to use this project as a success story to show what can be done when an organization such as ours is proactive to a problem.
