We continue to have surgery dates and offer these to the community so they have the chance to help with the issue in their area. We have been awarded this grant before and have the detail worked out so that everything runs very well. Our surgery coordinator works directly with our medical team to get these surgery dates, and we have continued to do them on a regular basis. We have the capacity continue to successfully use grant funding to schedule more community cat days and prevent unwanted litters.

We have chosen to work on the entire county, since the needs for assistance to alter community cats is everywhere.

In our county there are a large number of community cats. Without any low-cost clinics in our county, the numbers continue to rise every year. This puts a continuous strain on the community as well as local resources.

There is currently no low cost program in our county. Citizens have to travel to a different county or even to the next state over to find low cost options. This is not sufficient to meet the needs of our community. We want to provide local resources so that we can help our community as well as work on stopping the issue at the source.

## Objectives

**What do you hope to accomplish with these funds (objectives should be specific and quantifiable)?**

Santa Rosa County Animal Services hopes to perform an additional 500 spay/neuters with this grant. This will prevent multiple litters from reproducing and make an immediate impact on the area the community cats came in from.

**How does this program increase the number of sterilization surgeries above the existing baseline?**

This program allows a specific amount to be dedicated to our community cat program. While we continue to spay/neuter cats throughout the year, our number of available surgeries varies each year depending on the budget as well as any grants we have received. This grant would allow us to earmark a specific amount so that we can alter 500 cats in addition to what we would normally be able to perform surgery on through the year.

## Methods

**What criteria will you use to determine eligibility for your program?**

We will use our criteria as we have for the previous grants. Any citizen with a community cat that is located in our county can be altered through this grant. The cat must be a minimum of 3 months old. The citizen must be willing to bring the cat in and pick up the following day.

**How will you advertise the program? Explain how the advertising will reach the target audience.**

We have multiple ways of advertising for our community cat program. We use facebook as our primary source and have found it to be highly successful. We also post on our website, and spread the word through our various media sources such as radio and blog talk shows. Our officers are also sharing this information in the field with problem areas.

**How will you address barriers to full use of the program such as transportation, illiteracy, and cultural hurdles?**

We have not found any issues that we cannot work out. Our officers have worked with citizens for transport when necessary. We dont require excess paperwork for our citizens so any literacy issues can be handled with our staff. We also aim to work with every citizen needing help, regardless of any culture differences. Our staff is respectful and helpful and will do what we can to make sure to help every citizen.

**Does this project involve the transportation of animals by someone other than the client? If so, describe the vehicles, methods for confinement, personnel training, liability releases used to assure the safety of the animals and handlers.**

During our public community cat days, we have the citizens bring in the animals directly. We do have a Friends Of group that is highly involved in our community. They have been able to work out transportation previously to assist citizens that need a hand. Also, our officers will work with a citizen on a specific pocket, and they try work directly with the citizen to alleviate any issues. Our officers are trained to safely handle these animals so there is no issue. For citizens bringing in community cats, one of our requirements is the cat be in a humane trap. This allows for safe transportation and handling.

## Veterinary Services

### What arrangements have you made with veterinarians to perform the surgeries?

Our in-house veterinarian will be doing the surgeries for our community cat program. We generally schedule 2 days per month to get these cats in. In the event we fall behind or see a need for more immediate action, we have a low cost clinic that we have worked with before that is willing to allow us to have bulk surgery days as well. So we feel that we are well covered to make sure we utilize services to knock out 500 surgeries in a quick and efficient manner.

We will schedule community cat days for our citizens at no cost to them. We are able to do a set amount each surgery date. We expect to be able to get these surgeries completed well before the end of the grant period.

### **Describe any expenses that are not included in the grant and how they will be paid for (for example, vaccines, microchipping, ear notching, etc.):**

Santa Rosa County Animal Services will be paying for any addition services provided. We provide rabies and fvrp as well as ear tipping and flea prevention for each cat that comes in for the surgery. This allows the cat to have a good baseline for health once they are released back out. We are committed to the care of the community cats so we are taking on this cost in order to provide more detailed care for that visit.

### **Describe any other funding sources for this program, i.e. other grants, targeted fundraising efforts, budget allocation, etc.**

Our organization works hard to continue to fundraise throughout the year and raise money to go to our various programs such as community cat support. We have utilized grant money from other awards in the past to continue to spay/neuter community cats so that the problem is being addressed at all times. However, the need is great so we know we can not let up. Our county budget has allowed us to continue with this support as well, and our plan is to supplement the 500 surgeries this grant would cover with additional funding through grants and other efforts.
